Job Title: Clerk—Processing

Status: Non-exempt

JOB SUMMARY

Under the direction and supervision of the Technical Services Supervisor, the Processing Clerk prepares new materials for the Library collection. Inspects, cleans, and repairs Library materials.

DUTIES AND RESPONSIBILITIES

A. Essential Functions

1. Understands and practices the Mission of the Niles Public Library District (Library).
2. Provides uniformly gracious and friendly service to all internal and external customers.
3. Has working knowledge of Library policies and procedures, with a commitment to carrying them out at all times, while safeguarding confidential and restricted information.
4. Achieves the level of computer and technological proficiency needed to perform job responsibilities.
5. Demonstrates a patron-centered attitude.
6. Processes new materials for the Library's collection.
7. Assists with developing new and revised processing procedures.
8. Reprocesses existing materials to meet current requirements, giving input to help organize large projects efficiently.
9. Using the Library's integrated software, edits item records (format changes) according to the Library's procedures.
10. Repairs, inspects, and cleans Library materials, both print and audiovisual.
11. Monitors inventory of processing supplies and prepares orders as needed.
12. Attends staff meetings, conferences, and educational opportunities as appropriate to the position and within the budget.

B. Secondary Functions

1. Performs other duties as assigned by the Technical Services Supervisor.
2. May handle bindery shipments.
3. May help sort donations and maintain materials in the continuous sale room.
4. May substitute for other Technical Services clerks as needed.

REQUIRED KNOWLEDGE, ABILITIES, AND SKILLS

1. Ability to communicate and work effectively (both individually and as a team member) with the public and all levels of Library staff with tact and diplomacy.

2. Ability to work with minimal supervision, making decisions within stated guidelines to solve problems and to produce accurate work on a timely basis.
3. Ability to organize, prepare, and present information in English, both verbally and in written form.
4. Ability to demonstrate basic computer skills using Microsoft Office products.
5. Ability to be flexible and adaptable to new situations.
6. Ability to troubleshoot.
7. Ability to represent the Library in a professional manner.
8. Ability to work in an office environment.
9. Understanding of the role of Technical Services in carrying out the Library's mission.
10. Ability to follow established procedures for Technical Services tasks.
11. Attention to detail and neatness of work.

PHYSICAL DEMANDS

1. Work includes prolonged sitting, as well as repetitive keyboard use, moderate lifting, carrying, reaching, stooping, pulling, and pushing activities. Manual dexterity, clear speech, hearing acuity, and correctable vision are also required.
2. Ability to occasionally lift up to 25 pounds. Ability to transport/move up to 100 pounds of library materials.
3. Must park in designated areas.
4. Reasonable accommodations to these requirements will be made as needed.

EDUCATION, EXPERIENCE, AND TRAINING

1. High School diploma.
2. Ability to apply the principles and practices of Technical Services effectively.
3. Any combination of education, experience, or training that satisfies the requirements of the position.

ADDITIONAL REQUIREMENTS

1. If not a U.S. citizen, has a valid work permit.
