Skokian identified as 'Plumber Rapist'

Sheriff Richard J. Elrod announced the identification of Brad J. Lieberman during a lineup on Friday, Jan. 4 by 6 women who were victims of sexual attacks. Lieberman, a 19-year old Skokie youth, is believed by police to be responsible for more than 15 rapes and attempted rapes in Northern Cook County over the last 6 months. Elrod praised the close cooperation between Cook County Sheriff's Police, Chicago Police and the Cook County State's Attorney's Office which resulted in Lieberman's arrest and indictment, so far, on 7 charges of sexual attack. Lieberman was arrested in his home at 9008 Lamon in Skokie on Dec. 29 by Cook County Sheriff's Police and Chicago Police officers. He was identified shortly thereafter by 9 women who had been attacked by the infamous "Plumber Rapist" in Chicago, unincorporated Cook County, Evanston, Skokie and Prospect. Continued on Page 21

Conservation measures initiated after study results

Energy saving program in District 63

After a further study on cost savings, an energy conservation program will be effected by East Maine School District 63. An initial study was presented by Joseph Irpino, the District's director of buildings and grounds at a regularly scheduled board meeting Jan. 8 in Apollo School, 10100 Dec rd., Des Plaines. Conservation which would take place with no expenditures include lowering thermostats, turning off air conditioners at night, using cold water for cleaning as much as possible, keeping storage rooms unheated, closing unnecessary lights and turning off hot water heaters when school is not in session. Other steps, such as weatherstripping, changing convection lighting to fluorescent, eliminating incinerators and installing compactors, and installing turbulators, would be more costly. Irpino cited several Continued on Page 21

But beginning this year we're going to soften up on old Nick. No more punching the green kid around in print. He's suffered and we didn't mean for him to show so much pain.



MG emergency snow plan

To continue providing the best snow removal service in the area, the Morton Grove Board of Trustees recently passed ordinance 79-46, "An Ordinance to Enact Parking Restrictions During Winter".

The new ordinance provides for implementation of parking restrictions when a snow emergency is declared by the Mayor.

It also provides for towing or relocating vehicles which impede snow removal efforts and it additionally prohibits anyone from depositing snow upon the streets and thoroughfares or public sidewalks. "These two provisions of the ordinance apply all winter, whether or not a snow emergency has been declared by the Mayor."

Morton Grove Mayor Richard T. Flickinger explained that "in developing a plan for responding to a repetition of last year's heavy snows we were particularly sensitive to enacting an ordinance which would cause the least inconvenience to residents, shoppers and businesses while also affording the Public Works department the extra margin necessary for the prompt and most cost-effective clearing of snow clogged streets."

If a snow emergency is declared, parking will be permitted only on an "Odd-Even" basis, with parking permitted on odd-numbered days of the month only on the side of streets with odd-numbered addresses. On even-numbered days of the month the opposite will be required.

Mayor Flickinger explained that the Board of Trustees saw no need to inconvenience residents by requiring everyone "to jockey their cars around every day, even when the sun is shining and the streets are clear and dry." The plan developed by the Village will go into effect only when necessary to clear the streets of snow such as we experienced last year.

Mayor Flickinger said that if the situation warrants a snow emergency being called, residents would be notified through various channels, including announcements made in the schools, churches and synagogues, public address equipment on Police vehicles and temporary signs erected on the designated streets or intersections within the Village.



Niles Library Board election set for April 8

sooner than the 15th day of January and no later than the 1st day of March, 1980. Forms for petitions may be obtained at the library office any time during regular library hours.

Dr. Lee participated in many scout world jamborees, in Hungary, France and England, where he met and worked with the founder of Boy Scouting, Lord and Lady Baden Powell.

Dr. Lee, who was born Lechinski, became a U.S. citizen in 1952, and among his other accomplishments, served as Professor and Chairman, Dept. of Psychiatry and Mental Health, Chicago College of Osteopathic Medicine, was a Fellow of the American Otolaryngic Assn., a member of the editorial board, Journal of Existential Psychiatry, and an honorary member of many professional and scientific U.S. and international societies, academies and institutes. He also served as a visiting professor of pastoral psychiatry at the Jewish University of America and at Hebrew Theological College. He was wounded and captured by Nazis during WW2 and subsequently sentenced to a concentration camp. He received scouting's Silver Beaver award, scouting's highest honor, in 1973.



Skokie officials compliment residents for cooperation

Skokie officials were pleased with both the plowing efforts and citizen cooperation during last week's initial snowfall of the year. While the snowfall did not warrant calling a snow emergency, the 4-in. accumulation did prompt Skokie to plow and salt all of its arterial and residential streets. Village Manager Bob Eppley said that he and Public Works Chief Bud Hohns were pleased with the plowing efforts. "Some of the new plowing procedures we've put into effect worked very well," Eppley said. Eppley said reports from police

and public works personnel indicated that residents were very cooperative. He cited the increased number of snowblowers being used, removal of cars that had previously been undrivable (flat tires, etc.), and excellent cooperation with village personnel. "We're heartened by what we saw in this first snow, even though it wasn't an emergency situation. I think the memories of the hardships of last year aren't gone from people's minds," Eppley said. "I'm sure that when the sirens go off and our police go around with their loudspeakers

announcing a snow emergency, we will get tremendous cooperation from our residents." Eppley reminds residents that when an emergency is called, special parking restrictions go into effect. "Residents should be alert to this when the conditions appear bad and we have had an accumulation in the area of 4 to 5 inches or more. Listen to the radio and television for reports on whether we are calling an emergency," Eppley said. When residents believe an emergency may have been called, they can call the village's special number, 675-SNOW. They

can also listen to WPRZ radio (1330 AM) for special snow reports at 10 minutes after each hour. Eppley urges residents to be ready for bigger snow storms by removing from the street any vehicles that are in disrepair or simply are not usually driven (to avoid towing); helping neighbors shovel and remove stalled cars; and by maintaining their car for winter with snow tires and proper maintenance. "All of this will help you and the village government cope with the coming storms," he said.

tired of home life. I don't find too many straights coming in. Not that we are all perverts or screwed up, but obviously there are other reasons for getting into it than what should be the basic reason, because I want to help the country, I want to help my party. We don't have that anymore. I would never advise anybody to get into politics at the level I am in, as a committeeman."

That's some kind of a quote. Can you imagine a guy in political life being that candid? How would you like being a woman working in Blase's Maine Township organization and having the top guy say many of them are there because "they want to start fooling around a little bit"? And how'd you like to be a loyal precinct worker and then read the guy who you've been pushing bells for the past 20 years doesn't think many of his people are "normal, stable people"?

Nick is much too harsh, both on his people and on himself. The megalomania he sees in public life carries over into all sectors of life. A guy who starts a newspaper and likes to see his name in print has that same megalomania he's talking about. The insulated intellectual community of university people reeks with a similar megalomania. Just spend an evening with a group of professors.

This conceit carries over everywhere. The man or woman who seeks the president of his group, whether at the YMCA, Lions Club, or in his business suffers from exactly what Nick is citing.

All of us want to stand above the crowd in some way. We all want to excel a little more than the guy next door. Nick should ask himself why certain people drive certain automobiles. We've got the Mercedes-Continental crowd on our street in overabundance. Why?

Besides the big car syndrome there's the big house syndrome. Why do certain people live in the lavish homes they do? We have a Morton Grove acquaintance who, in her mid-fifties, has moved from a home which cost \$15,000 twenty years ago to one costing \$300,000 today. What is she trying to tell everyone?

Nick should understand the \$300 suits, the guy who wears his college degrees on his sleeve, the overpriced vacations, the hyped-up jewelry and furs one wears is all part of what he's talking about.

People who join political groups are of all sizes and colors just like everywhere else.

Perhaps the best example of exactly the opposite of what Nick said about political people can be seen right on Niles village board. We would venture to say Niles' present board is as stable a group of people as can be found on any public body. There's less ego, less playing to the crowd, and more selfless effort there than in most political areas.

Nick's candidness may be refreshing. But his view at the top has prismatic distortions which may be caused by looking too long thru a looking glass which views the same old landscape.

Heights. During the Jan. 4 lineup, which was conducted in the State's Attorney's offices at 26th and California, victims positively identified Lieberman as their attacker in rapes, attempted rapes and related crimes which occurred in unincorporated Maine Township, Northfield Township, the City of Chicago, Niles and Morton Grove.

The "Plumber Rapist" was first identified as a rape-pattern by Cook County Sheriff's Police investigators last September, after 3 attacks were reported by women living in apartment complexes in Maine Township and the City of Prospect Heights, which is patrolled by Sheriff's Police. These victims, all of whom subsequently identified Lieberman as their attacker, told investigators that the rapist gained entry to their apartments by telling them he was looking for leaks in their water pipes.

Cook County Sheriff's Police investigators based at the North Investigation Section, 8973 N. Milwaukee, are seeking other possible victims in the case. Anyone wishing further information should contact Lt. Frank Braun at 865-4930.

examples of the District eventually recuperating the funds through energy savings.

Board members as well as the public were invited to submit ideas to aid conservation. Irpino said, "It's everybody's problem."

Dr. Richard Hetke, Stevenson school principal, and Milo Heilman, Washington school principal, gave board members a report on the Early Retirement Program for certificated personnel such as teachers.

They said the State of Illinois has approved a plan for teachers, ages 55 to 60, who want to retire. According to the plan, teachers who have served the State a long time and are at the top of the salary schedule would be permitted to retire early with the incentive for doing so. Younger teachers earning less money would replace them.

The District has an option of implementing another plan for teachers ages 60 to 65. Both plans would include severance pay and, if eligible, certain increments. Board members said they would like to see examples of costs for certain age groups. They also said this would be easier for teachers to understand how it affected them.

In other action, the board approved ratification of the collective bargaining agreement with the East Maine Teachers Assn., and approved replacing the duplicating machine at Stevenson School.

James Bowen, business manager, censured the paper put out by the Illinois Education Assn. He said the writer was mistaken in writing that District 63, among other districts, lost revenue through business management which was not fully aware of the Illinois tax system.

Also, the board approved the awarding of a contract to Action Fire Equipment for \$935, approved a maternity leave of absence and an extension of leave of absence, appointed three teacher aides, approved a change of position and change in salary and approved an agreement for extra duty.



Aftermath of an American tragedy -- The death of Betty Coed

Voltaire, the French philosopher, once said: "Youth is a blunder, Manhood a struggle. Old age a regret."
Perhaps, if he had added "Life is a tragedy" he would have succinctly said it all.

She was young. A coed, home for the Christmas holidays. She was fairly bursting with the joys of the season and dreams of hope. The magic spirit of the Christmas season had permeated her -- as it does most -- except the very, very old or the very, very poor, who, in most cases, have an unfortunate affinity.

Her name was Betty Quinn of Chicago. Laughing and talking one moment, a split second later she was dead. A slug from a 9 millimeter automatic tore thru her eye, brain and skull.

Betty Coed was dead!
It could have been you or me or anyone else.
How do you explain a tragedy like this?

Perhaps, if I were to paraphrase from Mario Puzo's recent novel, she was just an X in an indeterminate equation. Maybe we are all X's in this unsolvable equation?

Now, even the chalk marks, the X where the body remained, are washed away, like footprints upon the sands of time.

Few (except those near and dear to her) will really care -- nor long remember.

Last week's Bugle had two excellent columns. One was Dave Besser's, the publisher. The other was Diane Miller's, our managing editor.

It is with this latter column, Miller's, that I shall embellish a little. Having little time, and few facts, Miller, who didn't even use a byline, dashed off an excellent front page story about the tragic end of Betty Quinn. The offender, who is alleged to have caused this tragedy, is as young as the victim. His name is Kurt Bartall, 7321 (Miller had the address as 7123) N. Octavia. He is the son of a 25 year veteran Chicago policeman with the traffic investigations unit.

Bartall, Jr., unknowingly, must have had a date with destiny the night he was nabbed. As the man did in the classic short story who tried to avoid death by going to Sumatra. He honked his horn at a young woman at a traffic signal. Apparently, angered because she didn't move her car fast enough, he fired a

slug at her car at a nearby intersection. (Her name is withheld because she's a juvenile.) This juvenile promptly came into the Niles Police station, told what happened and gave the cops his license number.

Subsequently, a Niles patrolman, officer Leon Elsing, Badge No. 127, spotted the car parked in front of a small shopping center. A juvenile gal was in the car. Officer Elsing, the arresting officer, called for back-up. When Bartall, Jr., approached his car he was arrested and taken to the Niles Police Dept.

According to Detective John Katsoulas, who supplied me with the facts for this story, Bartall, after considerable questioning by Niles police, finally admitted to firing random shots in the vicinity of 5000 Milwaukee at the time Betty Quinn was killed.

"The ballistics tests made by the Chicago police crime lab revealed the bullet that killed Betty Coed came from the 9 mm. Smith & Wesson automatic carried by the offender, Kurt Bartall, Jr.," said Det. Katsoulas.

This gun has been traced back to Owassou, Oklahoma. A man named Don Klahr owned it and sold it at a gun show there in 1975.

At a preliminary hearing held Monday, Dec. 31 in Branch 86 of the Criminal Courts Building at 26th and California, 21 year old Kurt Bartall, Jr., was charged with attempted aggravated battery, criminal damage to property, armed violence, reckless conduct and the unlawful use of a weapon. Bail was set at \$500,000 and reduced later in the day to \$250,000.

Later, on Jan. 4, the State's Attorney for the 3rd District added murder and attempted murder to these charges.

Sam, owner of the Niles House of Pizza, took exception to the fact our story said the offender's car was parked in front of his place of business. I agree with him. There are several other stores located in that small shopping center and the offender could have been in any one of them. But Sam, the owner of the Niles House of Pizza, did admit to me that the offender, Kurt Bartall, Jr., did, indeed, come into his restaurant and have an Italian beef sandwich. (Maybe the 16 year old girl in his car that night wasn't hungry or Bartall, Jr., had the shorts, or something?)

Incidentally, Sam, owner of the Niles House of Pizza, told me that Kurt Bartall, Jr., was a steady customer and always conducted himself as a gentleman.

"Ed," Sam said, "why a guy that was built like him needed to carry a gun beats me. Who'd want a tangle with a guy who was built like him?"

Beats me, too. Maybe this young guy saw too much violence on TV, when he was "blundering thru his youth". Then again, maybe manhood -- or being a man -- was too much of a struggle for him. About "old age" being a regret, well,

I dunno, but after 69 years of livin', I've found guys like that usually don't have to worry about "old age".

Me, maybe I'm like Mario Puzo ... just an X in an indeterminate equation. But, then, that beats the hell out of being a zero!

Following the Tuesday night board meeting Tr. Carol Panek observed that the new code "should provide for new code in both departments."

In other action Tuesday evening the village board presented a plaque to retiring Ralph Tencate of the Niles Fire Dept. in recognition of his 20 years of service and in grateful remembrance of dedication of the community. Blase bid good luck to the firefighter who, he said, "observed a young fire department grow over the years and who was a part of the numerous awards won and honors paid to the department."

Approved a plat of subdivision by ordinance of the Harbor Trees First Subdivision on Golf rd.

Mayor Blase noted the sole purpose of action by the Village Board was intended to record and protect leases presently located on the J.C. Penney Treasury lot.

With zoning to remain commercial he noted Lot 1 (the Treasury, no longer in existence) will be leased to a major tenant with no change in exterior framework. Bennigans, a restaurant, remains on Lot 2; Evanston Savings & Loan on Lot 3; a gas station (Penneys) on Lot 4. Lot 5 is undeveloped.

Unanimously approved a motion to re-let bids on village property located at 8229 Waukegan rd. and 6964 Fargo ave. Noting that no bids had been received on the two lots to date Blase said on advice of counsel the two pieces of property will be offered again for sale.

Planners recommend another shopping center

The Niles Plan Commission and Zoning Board Monday night, Jan. 7, recommended approval, 5 to 1, of rezoning from business and residential use to business of 3.79 acres at the southeast corner of Greenwood ave. and Ballard rd. for a one-story "specialty shop center with small tenant users" but withheld a petitioned Special Use permit on the property.

Comr. Patton Feichter, the lone objector, indicated he preferred to hear more information of the 7 points of objections to the Center proffered by the East Maine School District 63 attorney, Lorence Slutzky.

The plan commission previously turned thumbs down on the original proposal last July by then-owner and developer Robert Krilich of Riverwoods Development Co. on the 9.5 acre site at 8954 Greenwood ave. for a planned unit development.

More recently a change of ownership Sept. 10 of 3.79 acres to new owners Attorney Bernard Davis, George Dravillas and Angeli Angelos resulted in a rezoning proposal Dec. 3 of the property for a "boutique-type" shopping mall of one-story businesses and one four-story office building set at the north end of the site. The rezoning petition had been continued to Jan. 7 for classification of specifics requested by Zoners.

Revised plans Monday night under a land trust of the three new owners removed the concept of offices, making the entire project a complex for shopping. Traffic access on Greenwood was also changed to a single entrance

directly across from the Gemini School driveway.

While school attorney Slutzky told Zoners he had received the revised plans only shortly before the Monday hearing, he also indicated the 7-points of concern voiced by the School Board had been apparently resolved during the hearing.

A Special Use permit was rejected by planning commissioners after Director of Building and Planning Joseph Salerno pointed out there was a need for the permit, with the exclusion of an office building proposed for a 48 ft. height which was over the 36 ft. height limit permitted under village code.

When Planner Gerald Estes protested the permit was needed for possible special uses, of a Child Care Center, Health Club, Trade School, pet grooming shop and a Savings and Loan institution for the area, Salerno said Special Use permits are only granted to specific businesses dependent upon location and size.

Plan Commission Board President Jack Frick agreed, stating that "blanket" permits for special businesses are not issued.

In other action Monday night Zoners permitted "spot zoning" in a 5 to 1 approval of petitioned rezoning from business to multiple family and variation from 7,800 ft. to 7,600 ft. of property at 7457 Waukegan rd.

While the northeast corner lot is fronted and sided by businesses on Waukegan rd. zoners said numerous callers who desired a business location were dissuaded by a lack of parking in the area.

Ted Henderson, developer and associate of owner Alfred La Cerra, proposed a 2-story building which would include two 3-bedroom apartments and one 2-bedroom apartment. Existing elevations along Waukegan rd. he explained would result in a 2½ story building on Waukegan frontage with the building dropping to a 3-story building at the rear (east side).

Comr. Angelo Troiani as the lone dissenter said he was concerned over the height (not discussed during the hearing) of the building.

Commissioners unanimously approved a variation request by Mrs. Jeanne LaBon of 7345 Breen st. in rear yard setback from 40 ft. to 36 ft. for construction of a "nice" family room.

The 25 ft. addition she told zoners would extend from the kitchen area of her home.

• Voted to have stricken from the record a petitioned Special Use permit for storage of vehicles by Robert Bauer at 8220 Oakton st.

Zoning Director Salerno said no communication had been received from the petitioner whose case had been continued from Dec. 3 due to illness of the petitioner's attorney.

Approximately a dozen people who had come to the hearing on the petition left the courtroom following action by the Plan Commission.

Progress report on administration building

Morton Grove Mayor Richard T. Flickinger said recently that progress on remodeling the Grove School into the new Administration-Police building is slower than expected but he anticipates occupancy of the facility later this year.

The building, at 6101 Capulina, required extensive remodeling and modifications to fit the needs of the Police and other Village departments which will come together under one roof with ample parking adjacent to the building.

Also included in the facility will be an area designed for the exclusive use of senior citizens. This portion of the remodeling is financed by a separate federal grant and work on this section of the project, Mayor Flickinger said, has just begun following the

awarding of the contract for this specific work.

Seniors will also have access to use the council chambers, the Mayor added.

"Services and activities at the new senior center will be developed to respond to the needs and desires of our older residents," the Mayor explained. "This facility, in addition to the activities provided by the Morton Grove Park District, will offer an increased number of services to my fellow seniors."

The remodeling project is financed by a 2.1 million dollar bond issue. Mayor Flickinger pointed out that although the construction is taking longer than anticipated, "the work is a contract job and the cost will not exceed the amount of the bond issue."

Skokian seeks seat on Regional Board

Linda Lang, of Skokie, is running for a six-year term on the Regional Board of School Trustees.

Lang, a 29 year old with a master's degree in education, filed her nominating petitions for this suburban Cook County-wide office on Dec. 10. She is seeking one of two six-year terms available in this March 18, 1980 non-partisan election.

The Regional Board has jurisdiction over all of suburban Cook County in deciding boundary questions and disputes involving elementary and high school districts.

"With declining enrollment and the associated problems for suburban districts, the function of this board is becoming increasingly important," Lang said. "I will try to inform suburban residents about the functions of this board, and then as a board member I will help in the decision-making process," she added.

Lang taught and helped develop curriculum in Lincoln District 74 and taught a pilot program in Skokie District 73½. She has a master's degree in curriculum and instruction from National College.

The American colonists brought very little gold and silver with them and found only insignificant deposits in the colonies. In return for their exports, they preferred to import tools and other manufactured goods rather than gold and silver for monetary purposes. Many nonmetallic commodities such as wampum, beaverskins, tobacco and rice, as well as a variety of paper issues, were widely used in monetary capacities. The coins that did circulate came chiefly from the West Indies and were mostly of Spanish origin, with the Spanish dollar, or "pieces of eight", leading in popularity. All foreign coins, non-metallic commodities, and paper issues, were from time to time, made legal tender for the payment of public and private obligations.


