Sewer controversy delays shopping center approval

The Niles Village Board of Trustees agreed Tuesday evening to postpone decision on the shopping center proposed for the corner of Ballard and Greenwood. The new center which will consist of 20 to 40 stores depending on the size required by leases will consist of 3.79 acres

with a 708 front footage on Greenwood. Gerald Estes, project planner for the proposed center appeared before the board and stated that present plans for the water drainage include running it into the ditch in the back of the property until the adjoining Krilich property is developed. At

that time the water drainage will be enclosed in a box culvert within the right of way on Ballard rd.

Trustee Peter Pesole immediately questioned the planner on his statement noting that it did not coincide with his understanding of an agreement made during a recent bus ride taken by

board members, the village manager, and engineering to study the layout of the property and the water drainage problem.


Mayor Nick Blase told Estes, "You purchased the property from Krilich. You should make arrangements with him to determine how this water is going to be drained off the property."

Trustee Ang Marcheschi stated his concern over the sewer system north of Ballard to Maryland noting that "we do not want to have any problems in this area which taxpayers will have to pay for in years to come."

At this point Village Manager Ken Scheel told the board a com-

Political Bits ...

...Morton Grove's Home Rule referendum is very confusing. The wording on the ballot reads: "Shall the Village of Morton Grove, County of Cook, State of Illinois cease to be a Home Rule unit of government?" If you favor retaining Home Rule, then you should vote "No". If you support eliminating Home Rule, then you vote "Yes".

Congressional candidate Tom Flynn reports the turn-out for Teddy Kennedy at Niles West High School's auditorium last Friday was much more enthusiastic than was reported in newspaper accounts. Flynn said Kennedy received a 5 minute ovation when he was introduced.

Flynn's report is likely to be accurate since he said he has switched his support to Jimmy Carter. He said he had contributed \$1,000 to the Kennedy candidacy and then Kennedy read from his script which included an endorsement for Flynn's Congressional opponent, Robert Weinberger. Tom said he protested Kennedy's action which he believed to be an added-on piece to his script, dictated by local politicians.

Chicago's Mayor Byrne and Maine Township Committeeman Nick Blase and Niles Township Committeeman Cal Suker are going to take a bath in next week's primary. They all jumped on the bandwagon with Calamity Jane by endorsing Kennedy, and Ed Burke for State's Attorney. If all the polls are accurate, Kennedy and Burke are both going down the tube next week, being swamped by their opponents. Ob-

District 63 Board discusses program cuts

Drastic cuts in programs throughout East Maine School District 63 were proposed to school board members as possible economies to deal with a possible deficit of \$15,831,553 by June of 1985.

Acting Supt. Donald Stetina prepared a list of possible cuts, their ramifications and possible savings to be reviewed in line with revised deficit projections

While voters will have a chance to vote for Democrat Lyndon LaRouche, Jr. or Republican V.A. Kelley for president in next Tuesday's primaries, most voters will be voting for the more recognizable candidates appearing on the ballot.

While much attention will be on the presidential primary, the Democratic race for State's Attorney between Edward Burke, backed by the Cook County Democratic machine, and Richard Daley, state senator and son of Chicago's late Mayor Dick Daley, is perhaps the most heated in Tuesday's election.

Presidential candidates in addition to LaRouche and Kelley included Democrats Governor Edmund Brown Jr., President Jimmy Carter and Senator Edward M. Kennedy. Republican

candidates are Congressman John B. Anderson, former Congressman and CIA head, George Bush, Congressman Philip M. Crane, former governor Ronald Reagan and Senator Robert Dole. Senator Howard Baker and former governor John Connally will be on the ballot though they've both announced their departure from the race.

In the races for the United States Senator Republicans include Attorney General William Scott, Dick Carver and Lieutenant Governor David O'Neal. Democratic senatorial candidates include Robert Ash Wallace, Dakin Williams, State Treasurer Alan Dixon, Anthony Martin-Trigona and Alex Seith.

Tenth District Congressional candidates include Democrats

Notre Dame coach named to Coaches Hall of Fame

Ralph Hinger, Assistant Athletic Director at Notre Dame High School, Niles has been named by the Illinois Basketball Coaches Association to the Illinois Basketball Coaches Hall of Fame. Mr. Hinger will be inducted to the Hall of Fame on April 26, at Illinois State University.

Mr. Hinger, a native of Chicago, graduated from St. Philips High School in 1945; the same year his team won the City Championship. He then graduated from the University of Notre Dame in 1950.

Mr. Hinger has been a Head Basketball Coach for 24 years. He began his coaching career at St. Vincent High School in Mt. Vernon, Ohio, from 1950-52. St.

Ignatius High School from 1955-1963, and has coached at Notre Dame from 1963 to the present.

In his coaching career at Notre Dame, Coach Hinger led the Notre Dame Dons to several conference and regional championships. Regional championships were won by the Dons in 1966-67 and 1969-70.

Mr. Hinger was also honored by the Chicago Catholic League and has a place in the Catholic League Coaches Hall of Fame.

The Illinois Basketball Coaches Association is comprised of basketball coaches from Illinois teams. The association plans on honoring 60 individuals who have made outstanding contributions to Illinois Basketball.

Maine East senior gymnasts award nominees

Carmie Stornello, Captain of the Maine East Girls' Gymnastics Team, and Sr. Laura Laura Trojan, were both nominated for Outstanding Senior Gymnast of the Year by the Girls' Gymnastics Coaches Assn. Girls are nominated on the basis of sportsmanship, leadership, scholastic standing, and Gymnastics accomplishments.

Carmie's best events in competition were Bars and Beam, but she is also an All-Around gymnast. Her Sr. year she averaged an 8.6 on Uneven Bars, 8.0 on Vaulting, 7.9 on Balance Beam, and 7.8 on Floor Exercise, with an 8.0 All-Around average. Carmie was the Sectional Bars Champion the past two years, and earned her highest score all

Laura placed 8th in the State Meet with an 8.63 All-Around average, which was a tremendous achievement in view of the stiff competition and her limited experience of two years as an All-Arounder. Laura placed 5th in Vaulting at the State Meet on her Tsukahara vault which scored a 9.0, as well as earning a 6th place in Floor Exercise with 8.95. Carmie and Laura hope to attend Oklahoma State University next fall and continue their competitive Gymnastics careers.

Family Life

LOVE AND THE FAMILY

"One of the best ways a father can love his children is by loving their mother." A father responded to this by saying, "What about the mother loving the father?" Of course, the answer is yes-it is just as important for mom to love dad!

The main point in the first expression is that children learn from and are greatly affected by the love evident between their parents. Children are very impressionable and respond just as much and probably more to what is acted out as well as said.

Parents may expect their children to be loving and considerate of one another and not quarrel or fight so much. However, if they don't follow through with a reasonably good example of the request or expectation, then it will be more difficult for the child to follow through.

A couple in marital counseling had this dramatically demonstrated to them when their teenager attempted suicide because she could not take any longer the hatred, fighting, chaos and disharmony of their home.

Outwardly, the parents would speak of loving each other, or of the children being loving and considerate, but too much of the parents' time and effort was spent on hating and fighting. Their example spoke louder than their words and wishes as it does with all of us.

Fortunately, the parents began to do something constructive about working out some of their problems after the experience with their teenager. In a very real way the expression that opened this article became alive to them: "Parents can truly love their children by loving each other."

It is important to note that loving each other is not the only way to love your children. Your children also need your personal love, attention and understanding, just as you, as a parent, need your children's love, attention and understanding.

This is not a one-way communication, rather a two-way or multiple kind of communication. Frequently, I will hear from a mother or father in marital counseling that they never knew love in their home as a child.

The husband of a married couple (also parents; shared how difficult it was for him to be close and loving to his wife and child! He related how love was never really shown in his home.

He felt that his mother was starved for love and affection, which his father rarely showed. He felt that his father didn't know how really to show his love or be close to his mother or any of the children. He realizes how much his father missed, and he is now wanting to learn how to love, to be close so he won't lose out on his family as his father did. Also, that he won't have the devastating effect on his wife and children that his father had on his family.

Another case vividly illustrates the importance of loving each other. A grown child, married and a mother, had much difficulty in keeping her weight down. She would be consistently 100 or more pounds overweight. She went on expensive weight reducing plans. Although she would initially lose weight, she went right back to her "old self."

I came to discover that "old self" felt that something was wrong with her, that she didn't deserve to be loved. This was finally resolved after she heard from her father in a family session that he had never been able to be close to anyone.

Although he was quite a notable figure, had hundreds of admirers, etc., he had never been able to be close to anyone since his father's death. His father who was dying had said to him when he was quite young that he should never be close to anyone because it was too painful.

This woman (wife and mother) then began to realize that what she had taken as rejection was her own father's difficulty in being close to her, her mother or anyone.

Her weight problem soon disappeared and she began to really like herself. She now realized that her weight, which her father hated, existed because she could endure his rejection only as he would relate to her fatness, not to her as a daughter.

Erich Fromm wrote a book entitled "The Art of Loving". Love is an art and one we all need to work on.

Many men initially love their children by loving their mother. They feel more comfortable in the marital relationship. They need to develop the "art of loving" by in turn being able to love their children as well as their mother. This is true for women as well as men. Love is the key to happy family living.

Nothing can take the place or have the total positive impact on a marriage, family or individual as the practice, cultivation and day by day demonstration of love in the home. Truly, "houses are made of brick and stone, homes are made of love alone."

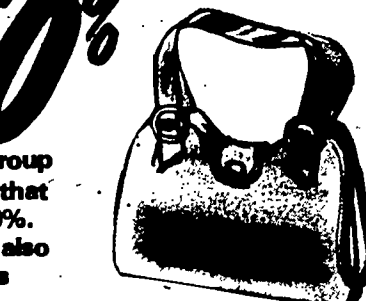

Veteran's program

A variety of benefits are available to persons who served in U.S. Military Service, their spouses, and their survivors through programs administered by the Veterans Administration. Long-term programs of V.A. compensation, pension, and hospitalization assist the veteran and his family with both monetary and medical aid.

Compensation benefits are payable to veterans who suffer service-connected disabilities. Veterans must demonstrate a medical connection between a current disability and a former service-incurred injury in establishing a claim for compensation. Surviving spouses and children of veterans who die of service-connected disabilities may claim Dependency and Indemnity Compensation (DIC) based on the loss of the veteran. Additional benefits of educational assistance and medical coverage may be provided where the compensation rate is 100% or where DIC is paid.

Pension benefits are payable to veterans of wartime periods who suffer from total and permanent disabilities not related to service. Pension claimants must meet income limitations. These limits are adjusted annually in the same amount as the annual Social Security increases.

Surviving spouses may also claim pensions if they meet income limitations. The rate of

pension is computed based on the countable income of the claimant. For the severely disabled veteran or surviving spouse, an additional aid and attendance benefit may be added onto the basic pension. Medical treatment is provided through the V.A. hospital system. The hospital's are available to all veterans, although priority treatment is provided to the service-connected veteran. Out-patient treatment for the non-service-connected veteran may sometimes be limited.

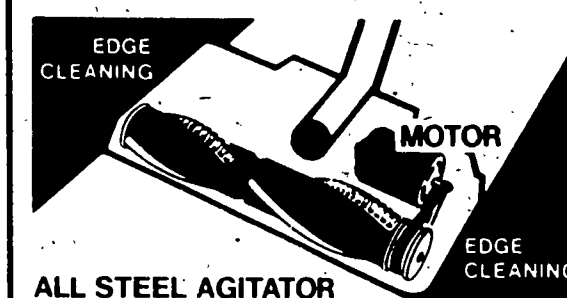

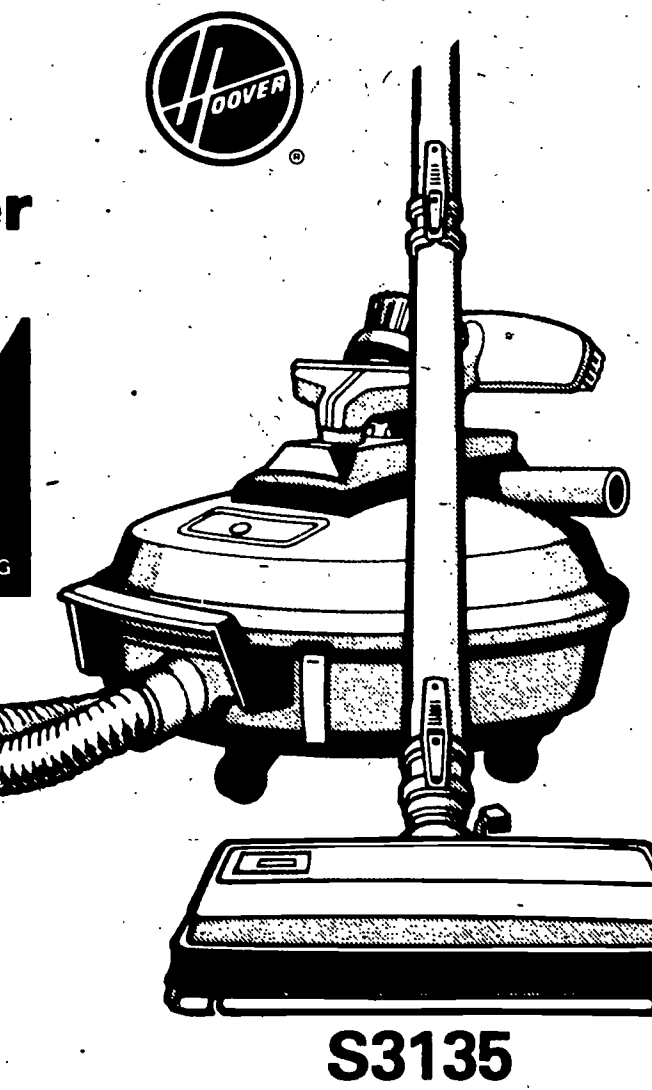

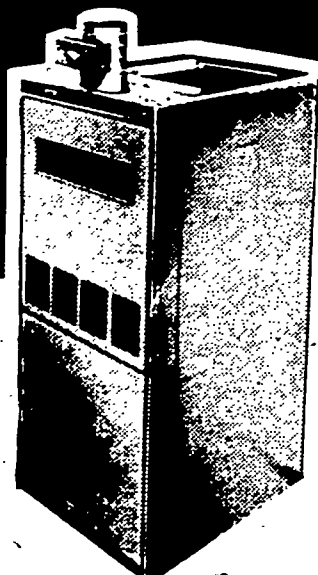

Junipers: Evergreens with Variety

Junipers (Juniperus species) are needle-like evergreens that are well adapted to harsh urban environments. There are over 170 species and varieties offered by American nurserymen across the country. They come in all different sizes and growth habits. Most are hardy in the Chicago area. Certain Junipers, particularly varieties of Eastern Red Cedar (Juniperus virginiana), have one annoying drawback—rust disease (Cedar-apple Rust and Hawthorn Rust). Susceptible Junipers act as alternate hosts for these two diseases on crabapple, apple and hawthorn. Rust infections on these three plant materials result in orange spots on leaves and fruit and leaf drop.

Following is a brief list of some of the more desirable species and varieties (clones) for the upper Midwest.

Juniperus chinensis (Chinese Juniper) is a highly variable species, ranging from ground covers to trees. Most varieties and clones of this juniper are rust resistant.

The variety 'Columnaris' is a narrowly columnar form with silvery-green, sharp needle-like foliage. 'Pfitzeriana', perhaps the most popular Juniper variety in the Chicago area, is a dense, very broad shrub. It has arching, plum-like branches with drooping tips and gray-green foliage. Two propagated offshoots of 'Pfitzeriana' are 'Pfitzeriana Compacta' and 'Pfitzeriana Glauca.' 'Compacta' is a compact, bushy form and 'Glauca' is more dense with bluish foliage.

Juniperus communis (Common Juniper) is a widely-distributed shrubby Juniper in North America, Europe and Asia. Most popular forms are resistant to both rusts.

The variety depressa (Canadian Juniper) is a broad, prostrate spreading shrub of two to four feet high. It has light to dark-green foliage and ascending branch tips. Not as ornamental as other Junipers of this form and size, but very tolerant to dry, poor soil. 'Hibernica' (Irish Juniper) is a dense, narrowly columnar form with ascending branches and medium blue-green foliage. 'Suecica' (Swedish Juniper) is a narrow, columnar form with spreading branch tips and light gray-green foliage.

Juniperus horizontalis (Creeping Juniper) is a species from which many selections have been made. Three outstanding selections for ground covers are 'Bar Harbor,' 'Douglasii' (Waukegan Juniper) and 'Wiltonii' ('Blue Rug', same as 'Wilton Carpet'). 'Bar Harbor' selected from native plants growing near Bar Harbor, Maine, is an extremely low-creeping form with blue-green foliage. The name is now used frequently in the trade for other low-growing forms. 'Douglasii' is a broad spreading form only six inches high with blue-green foliage which turns pale purple in the fall. 'Wiltonii' is similar but with a tendency to mound slightly. It has interesting blue-green foliage and texture.

Juniperus procumbens (Japanese Garden Juniper) was originally cultivated in Japan. It is an excellent low, spreading shrub, one to two feet high with light-green foliage. It is not as vigorous in growth as Juniper horizontalis. The variety 'Nana' is a handsome, slow-growing selection with rounded growth habit. Its branches tend to have a shelving effect, one on top of the other.

There are many others available. To plant Junipers, prepare the soil well so it is well-drained. Incorporate some compost or well-rotted stable manure in the planting hole. After planting, thoroughly water each plant and mulch four inches deep with wood chips.

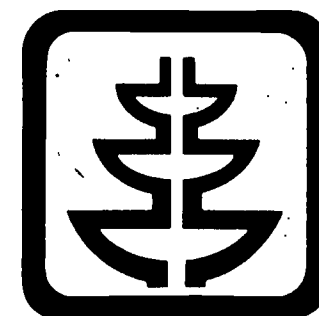

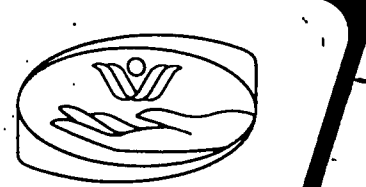

Jack coordinates Tam's Industrial Golf Leagues and supervises the operation during the year. At the present time Jack is

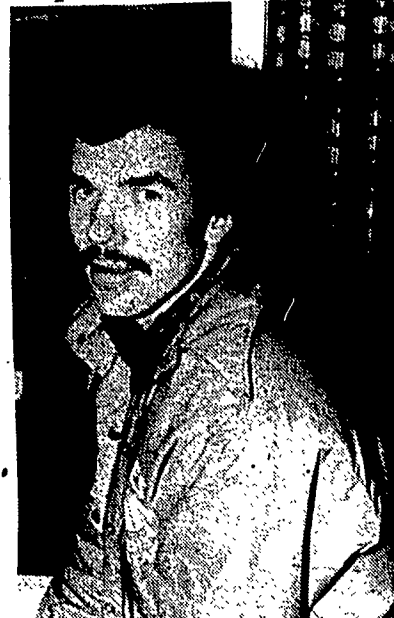
working on a new program at Tam for 13-15 year olds involving a Junior Golf League.

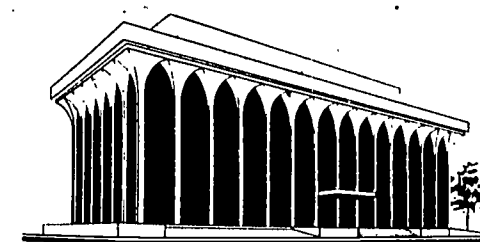

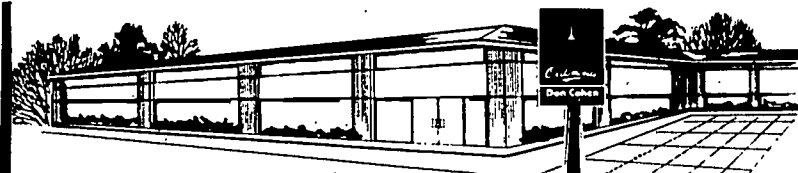

Nimrod, wife running for GOP delegates

Senator John J. Nimrod (R-4th, Glenview-Park Ridge) stated there will be no contest in the March 18 primary for Republican congressman in the 10th District. Republicans, after five years with no incumbent, will be able to re-elect Congressman John Porter who was elected in a special election Jan. 22nd of this year.

Senator Nimrod, who opposed Porter in the special primary in December 1979, withdrew in January as soon as John Porter was elected, saying it was not his policy to run against Republican congressman in general elections.

The Nimrod name will be on the ballot, however, as a candidate for Delegate to the Republican National Convention in Detroit. And voters won't be seeing double when the Nimrod name appears twice - on ballot lines 30 and 39. Dorothy Ingeborg

GOP delegate and alternate candidates

In the March 18 Republican Primary election, voters in the Tenth Congressional District will be asked to choose five delegates and five alternates to the GOP convention in August in Detroit.

Among the 20 candidates running for delegate and the 11 running for alternate, only two are from Maine Township—Dee Conroy (r) of Glenview, and Wayne Andersen (l) of Des Plaines. Both have been endorsed by the Maine Township Regular Republican Organization, and they are running as part of a slate of five delegate and five alternate candidates which has been endorsed by all five of the Regular Republican Organizations in the 10th Congressional District.

Dee Conroy, running for Delegate, is Maine Township Deputy Committeeman and also State Central Committeewoman of the 10th Congressional District. She is a past president of the Maine Township Regular Republican Organization and treasurer of the 10th Congressional District Republican Woman's Club.

Wayne Andersen, also a past president of the Maine Township Regular Republican Organization, is president of the Board of Directors of the local GOP group, and is running for alternate delegate to the national convention. Andersen is a Chicago attorney, and was a candidate for County Treasurer in 1974.

Nimrod, wife of the legislator, is also running for delegate. The husband-wife race for two of the five delegate spots to be selected by voters is a first in Republican voting history, according to a conversation with the Hon. Marguerite Stitt Church, our former Congresswoman, who has attended every Republican convention since 1936.

Although GOP delegates are running uncommitted to presidential candidates, due to recent legislation in the General Assembly and State GOP action, the Nimrods prefer to publicly acknowledge their presidential preferences. Sen. Nimrod prefers a friend and neighbor, Congressman Phil Crane, and Mrs. Nimrod would support Ronald Reagan, for whom she was Women's Chairman of the 10th Congressional District in 1978.

Other townships are represented on this endorsed slate of uncommitted delegates by W. Clement Stone of New Trier, former State Senator (1st) Bradley Glass of Northfield, J. Robert Barr from Evanston, Chairman of Cook County Republican Central Committee, and Dee Conroy, Maine Township.

Alternate delegates on the uncommitted slate endorsed by the 10th District's five Republican organizations are: Harvey Schwartz, attorney, Niles Township; Dan Hales, attorney and former Congressional candidate, New Trier Township; Robert Lee, Deputy Committeeman of Northfield Township; Margaret Wold, Committeewoman of Evanston Township; and Wayne Andersen, attorney, Maine Township.

"You have to count on the delegates making the correct judgement when the time comes to vote at the convention," Mrs. Conroy continues. "If you elect people with experience in political affairs, you have to rely on their good judgement and common sense to do the right thing at the right time."

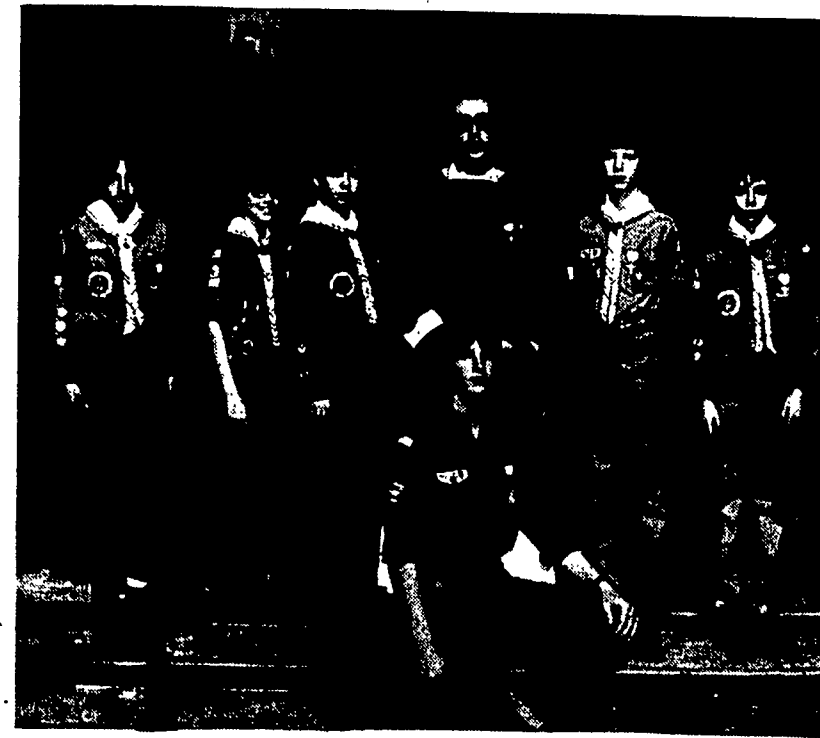

Flynn calls for action to free hostages

Thomas Flynn, Democratic Candidate for Congress, today called for immediate action to free the American hostages in Iran. He also called for immediate direct anti-inflation actions by the Congress.

Mr. Flynn said, "The only way to free the hostages is to force the Iranian government to take action against the student militants. I am calling for a total economic boycott backed by a naval blockade of Iran. Turkey and Pakistan should be asked to join us in our boycott and blockade. Once the Iranian government is isolated economically from the rest of the world the hostages will be freed."

He went on, "Our government must stop deficit spending and take the following measures to stop high inflation. The Congress must pass a national usury law limiting home mortgage and consumer credit interest. They must order a price rollback on gasoline, home heating oil and

natural gas. American savings institutions must limit their foreign investment to 20% of assets or deposits. The Congress must pass tax incentives laws to increase productivity. These concrete measures will begin to stop high inflation."

Mr. Flynn concluded, "Our hostages must stop paying the price of our freedom and working class Americans must stop paying for governmental incompetency and stupidity."

those days, you were checked out by the authorities for seven generations. If there is any blemish, in any of those seven preceding generations, you no longer become a copper in Italy, no a how, no a way. (I, then, thought back to a time, many years ago, when about ten per cent of the cops on the Chicago Police Department had felony records!)

But the significant detail, the thing that impressed me most and gave me a clue as to the fine character of these hard working Italian people was the preface of their menu. I repeat it, as follows, verbatim:

A Father's Prayer

Build me a son, O Lord, who will be strong enough to know when he is weak, and brave enough to face himself when he is afraid; one who will be proud and unbending in honest defeat, and humble and gentle in victory.

Build me a son whose wishbone will not be where his backbone should be; a son who will know Thee and that to know himself is the foundation stone of knowledge.

Lead him, I pray, not in the path of ease and comfort, but under the stress and spur of difficulties and challenge. Here let him learn to stand up in the storm; here let him learn compassion for those who fail.

Build me a son whose heart will be clear, whose goal will be high; a son who will master himself before he seeks to master other men; one who will learn to laugh, yet never forget how to weep; one who will reach into the future, yet never forget the past.

And after all these things are his, add, I pray, enough of a sense of humor, so that he may always be serious, yet never take himself too seriously. Give him humility, so that he may always remember the simplicity of true greatness, the open mind of true wisdom, the meekness of true strength. Then I, his father, will dare to whisper, "I have not lived in vain."

viously, they all tried to create an early bandwagon rush for their candidates.

If Richard Daley wins, you can expect the entire term of Jane Byrne to be shrouded with controversy. There's an obvious power struggle there. And with the magic of the Daley name, you can be sure politicians all over Cook County will begin re-assessing their positions after Tuesday's Daley victory.

"We'll have a difficult time next Tuesday when we go to the polls. There are several Democrats who would like to vote for but may forfeit voting for them because we're considering for the first time voting for a Republican presidential candidate. Following the lead of The New York Times, we are leaning toward voting for John Anderson for president. Under the headline, 'Why Not the Best?', the Times notes: 'The first thing people say when John Anderson's name comes up in talk about the 1980 election is something like, 'You know, he may be the best man in the race, and one who appeals to Republicans and Democrats at that. Invariably, the next sentence is something like, 'Too bad he doesn't have a chance.'"

"It is not our purpose here to endorse Mr. Anderson for nomination or election. This is not the season for endorsements; the primaries haven't even started. But it is our purpose to ask about the odd gap between those two sentences. If a candidate is really that appealing, why shouldn't he have a chance?"

"The single most important policy test for Presidential candidates in 1980 is energy. Their positions on energy necessarily tell where they stand on foreign policy, inflation, even the price of gold. By this test, Mr. Anderson so far makes more sense than the other candidates. They all say they know America's neck is in the noose of heavy dependence on foreign oil. But aside from President Carter's worth-while, but minimal program, none seem willing to do much about it."

employees, sworn to secrecy, may see individual census answers, and there has never been any proven case of a census employee divulging personal information from a census. Not even another federal agency can see individual census answers, whatever the purpose.

The census information is vital for a number of reasons, and Skokie's village government is committed to helping the federal government get accurate and complete findings from this village. Here are some key areas where accurate information will help Skokie residents:

"A significant part of our local government's budget is based on revenues received from the state and federal governments. Many of these aid programs use census statistics as a fair way to distribute the funds. Some examples are revenue sharing, community development, education, job training, school lunch programs, and economic development.

"Congressional reapportionment will also depend on statistics provided by the 1980 census. For a fair reapportionment, providing us with proper representation in Congress, the information of the census must be accurate. The same process is true for state legislative reapportionment, which will be coming in 1980.

"The village's planning for the coming years will be aided by accurate information. Housing statistics will help in planning building developments, while age statistics will help the park district, library, schools, and village government plan programs, activities, and services.

Both Peggy Noble and Karen George will be competing in the National Championship at the University of Missouri later in March.

The OCC Men's Team placed eighth at the State Championships which were won by Parkland Community College in Champaign. The Raiders were led by Mark Buciak, Chicago, who placed fourth in the two-mile and sixth in the one-mile and Mark Skarning, Des Plaines, who placed sixth in the two mile. This is the seventh consecutive time that Oakton has placed in the top ten in the Illinois Community College Indoor Track State Championships.

presented by James Bowen, business manager, at a regularly scheduled meeting Tuesday in Apollo School, 10100 Dee rd., Des Plaines.

The five-year deficit projection took into account the state aid formula, enrollment projections, assessed valuation, the number of teachers and their salaries and other expenditures.

Three possible areas of saving for the 1980-81 school year were included in the report and dealt with support services, academics and school closings. Meetings will be held at 7:30 p.m. March 20 and 24 to further discuss proposals and gain input from interested persons. Copies of the proposal will be on display at each school and the administration building.

Economies could include a reduction of services, elimination of services, parent support or other measures. At the elementary level, art, vocal music, physical education will be reviewed. At the junior high school level, art, vocal music, home economics and industrial arts will be considered.

Several services included in the budget overhaul will be junior high school counselors, reading coordinators, librarians at the elementary level and learning disabilities resource aides.

Teaching English as a Second Language (TESL) program is now available at Ballard School. It was proposed the program be moved to another school building so class space now in use could be rented out.

The district now employs seven speech teachers and one speech and language specialist. A proposal would reduce this department by one and assign teachers where needed in the district.

Eight social workers and one social worker hired under P.L. 94-142 (the Education for All Handicapped Act) and two psychiatric social workers provide service to the district. Proposals indicate a reduction.

An instrumental music program is now being used by 384 students in grades 5-8. The

program employs three band instructors and one string instructor. Proposals range from eliminating the program, increasing fees or eliminating summer school.

Also listed for review were extra-curricular activities which the administration thought could be supplied by local park districts.

Other suggestions were the reduction of secretarial services, and reduction of lunchroom supervision.

Other proposals not yet discussed regarded school closings or an increased student-teacher ratio.

Some savings mentioned by school board members included a doubling up of duties by one principal and assigning him to two schools. Most board members indicated they would not like any program completely eliminated.

Richard Smith, board chairman, said, "We will attempt to keep budget expenditures in line with projections for each year." He called the proposals "a prescription for survival of the school district."

Several persons spoke regarding the consideration of teacher contractual obligations, reduction in class size, reading coordinators, cancellation of teacher workshops and the public's access to the proposals.

Cesare Calderelli, director of staff, said about 21 teacher positions will be gone due to declining enrollment. His report will be available to the committee of the whole.

Calderelli's resignation was accepted by board members at the same meeting. He will accept a superintendency in Iowa after being in School District 63 about 14 years.

In other action the board members accepted the resignation and appointment of classified personnel, approved a change in salary for classified personnel, approved a resolution providing for a school board election of two three-year members and approved the gross payroll and remittances for insurance benefits and retirement program.

ministration building will result in a net savings of \$2,000,000, an action which resulted from action under Home Rule. He also pointed to the low interest mortgages the village received for homeowners, as well as a comprehensive day care center ordinance and raising the drinking age to 21 years old, all actions which he said were done in response to the community's needs.

Ashman said villagers are averaging \$56 more for their village taxes this year based on an assessed valuation of \$10,000, an average home in Morton Grove. Noting this comes to about \$5 more per month, he said many services would have to be eliminated if much of the recent tax increase was rescinded.

The attorney noted Glenview and Park Ridge both defeated similar efforts to knock out Home Rule in their communities.

Former trustee John Hilkin spoke on behalf of those favoring eliminating Home Rule from Morton Grove. He cited the unlimited power to tax, without requiring submission to referendum as being an "awesome and dangerous power." He noted prior to 1971 Morton Grove had operated for 70 years without home rule powers.

He said under home rule the present village fathers have increased village taxes by 51%. He said the increase will yield \$900,000 in one year, which will cover most of the 1.1 million dollars the village fathers claim will be lost if Home Rule is eliminated.

Speaking politically he said the village tax rate has increased 76% in two years under the Action Party regime, while during the previous 8 years the increase was only 5% a year under the former administration, of which Hilkin was a part.

He noted while the village population is declining, 16 new patronage jobs have been created during the past 2 years. Legal fees have gone up \$19,000 in 2 years. A \$19,000 assistant to the Mayor has been created while the village has a \$33,000 budget director who should be doing the functions of the assistant Mayor. He said the Health Department budget has doubled without adding one professional medical person to its staff. He cited newly created engineering and village planner staffs which he said adds \$63,000 to the budget.

Hilkin summarized his position saying government must be placed under the direct control of the people by limiting spending powers of its officials. He asked voters to vote "yes" to defeat Home Rule March 18 which will force the administration to use the referendum process when they need more money.

Alert Morton Grove homeowners on necessity of permits

Morton Grove officials are working to alert homeowners to the importance of obtaining building permits. Due to the high interest rates of new home loans, the village is seeing a substantial increase in the number of residents opting to add improvements to their present homes.

Leonard Bloomfield, chairman of the Plan Commission, made a special address to the March 10 meeting of the Morton Grove Village Board on this issue. He explained that when residents obtain the building permits, they are appraised of situations which would eliminate costly mistakes.

"Some people forget that they live on substandard lots when they look to add on," according to Bloomfield. "They must sometimes get variations, whether it be a garage or a fence. It is not a pleasure to hear cases when people have gone ahead and done work and then are advised they are too close to their neighbors. Sometimes they have to take it down when they are in most requirements."

Bloomfield said that in most cases everything is worked out to the satisfaction of all parties. "Residents must realize we are protecting home values. It's logical and it's a lot cheaper than buying a new home to take a 2 bedroom home and add a bedroom and family room, but some lots were not designed for these improvements and people are in violation of their neighbor's rights."

Morton Grove Mayor Richard T. Flickinger stressed that the requirement of obtaining the building permits has often been a topic in village newsletters. "People have to realize most of this is for their own safety. Electrical inspectors don't cost them a dime."

Bloomfield added, "There are fines that can be levied but the village does not want to extract their money that way."

In another area of village improvements at Monday night's Board of Trustees meeting, a bid was accepted from M and A Cement Work of Itasca for a sidewalk and curb contract. The price quoted is \$2.27 per square foot for sidewalk replacement, \$1.87 per square foot for new sidewalks and \$10.78 per linear foot for curbs.

Citizens were reminded of the 50/50 cost split with the village if they wish their sidewalk replaced. Mayor Flickinger advised that there is no village in the Chicago metropolitan area that will pay the whole amount.

If sidewalks are deteriorated and the resident does not want to pay his share, the village will do patch work. If the village had to break up the sidewalk, due for example to water damage, the village will pay the bill.

Village Board members also voted to accept a bid from Arthur G. Dietrich of Milwaukee for a backup electrical generator at a cost of \$572 for Fire Station No. 2.

Village Attorney Martin Ashman had "good news to report" in a major lawsuit whereby many suburbs, including Morton Grove, were suing the city of Chicago due to a 30% overcharge in water rates. The Appellate

prehensive sewer study of the total area has been underway by Metcalf and Eddy, sewer study consultants for the past two years and is just about completed. The study involves a master drainage plan for the entire Niles area. The study, funded by a grant from the Federal Government, should be consulted to determine if further drainage from the proposed shopping center will create a hardship on homeowners north of Ballard rd. Mayor Blase suggested to Estes that they wait one month more and reappear before the Board on April 8 during which time the sewer study will be reviewed by Village officials. The developers agreed to the postponement.

In other actions the board approved the request for rezoning of the Krilich property at 8621 Ballard rd. from R1 single family to R4 multiple zoning. Myron Minulski, attorney for Robert Krilich appeared before the board stating a law suit is currently underway in the Circuit Court of Cook County against the Unit. Dev comments on the property. He noted his client's strong objection to the R4 zoning.

The Board okayed an ordinance which would provide issuance of cards to handicapped persons to be displayed by them on the sun visors of their autos when they park in designated spaces for handicapped persons. Since Jan. 1 the village has authority to ticket any cars parked illegally in these

designated handicapped parking spaces. Village Manager Scheel noted all towns in the north and northwest suburban areas are honoring this card system and the implementation of it will correct the current abuse of this parking.

Board okayed purchase of property at 7169 Milwaukee ave. (at Touhy) for \$130,000 by the Village of Niles for landscaping and off street parking in conjunction with the Milwaukee ave. beautification program.

Board approved request for increase in seating from 7 to 15 at 7301 Milwaukee ave. (Little Vera's Kitchen).

Approved rezoning of indoor movie theatres from B-2 Service Business to B-2 Special Use giving the village authority to control the ingress and egress of proposed theatres. The ordinance also increases the parking requirements from one space for every 4 seats to one space for every 3 theatre seats.

Bids were opened for the 1980 Sidewalk and Curb program. Bids were received from 2 companies, but since there seemed to be a discrepancy in the listing of the prices, the bids were referred to administration with recommendations back to the board.
