District 63 Board ok's 3 year contract for Bond

Board members of East Maine School District 63 began the school year by reappointing the present superintendent, Dr. Donald Bond, approving about 200 salaries and tentatively ratifying a contract with the East

Maine Education Assn., a teachers' union. Action took place at Apollo school, 10100 Deer, Des Plaines.

Bond is the recipient of a three-year contract with the district for \$48,576 per year. Before coming

to this area, he served as a high school superintendent in Joliet, Ill.

First Village to file suit over controversial one per cent tax

Niles to sue Chicago over sales tax

The Village of Niles will file suit next week challenging the legality of the City of Chicago's controversial sales tax law which imposes a one per cent tax on merchandise sold outside Chicago to Chicago residents.

The proposal to sue Chicago, made by Niles Mayor Nicholas Blase during Tuesday night's Village Board meeting, apparently caught some trustees by surprise. While Niles trustees voted unanimously to initiate the suit, Trustee Carol Panek said, "It's all brand new to me. I didn't know it was coming up."

Village Attorney Richard Troy said the suit will be filed "within a week" and he expects it will

move quickly through the courts and be heard by the Illinois Supreme Court within a month.

In becoming the first Illinois municipality to challenge the Chicago sales tax law, Blase noted that Niles is one of the twenty top municipalities in Illinois in sales tax revenues. The Chicago tax law, said Blase, "interferes with the normal process of sales in our community. We must not allow confusion to enter into the operation of these businesses."

In the midst of numerous financial crises, Chicago recently passed a sales and service tax law. The sales tax adds a one per

The \$500,000 upfront money Niles received for choosing its second choice Cable TV company has everybody uptight. Tuesday morning Village Trustees Ang Marcheschi and Orville Ottow dropped into our office to explain their views on choosing Cablevision. Their joint opinion can be read on Page 3.

Carol Panek, who headed Niles committee to study Cable TV, has a different point of view than the remaining two committee members, Ang and Orville. We ran her views 4 weeks ago.

The controversy shouldn't center around personalities such as Carol versus the village board. Yet, it is disturbing the chairman of the committee who spent more than 2 years studying cable companies was shunted aside when the final decision was made. Her choice, which was the same as most other northwest suburban communities which were involved jointly in studying Cable TV firms, was not chosen by Niles.

Friday, the chosen company, Cablevision, had local newspaper people out to lunch. Their representatives were brutally frank. One of them told us they don't believe in upfront money. He used the word "trick" in describing this process of upfront money, noting it was a bidding process and contended it was not good business to grease the palms of any village with such money.

The City of Evanston also signed a franchise agreement with Cablevision, the same company Niles signed with. But it received no upfront money. However, Evanston will have their system operating 6 months after the agreement is signed whereas Niles may have as much as a 2 year lag before it's activated here.

Niles Trustees' rebuttal on Cablevision choice

Dear Editor:

In a recent news release some questions were raised regarding the choice of a Cable Company for the Village of Niles. We will address ourselves to these points and why we believe that the selection of Cablevision is the right choice for the Village of Niles.

We, too, served for over two years on the Niles Cable Committee and we, as well as the other board members, studied all reports and proposals and traveled to other communities to observe existing cable operations in an effort to find the best Cable Company for Niles. On May 22, 1979, the Niles Village Board passed a resolution requesting the Northwest Municipal Conference to establish a committee to study the problems attendant to Cable Television in the Northwest Municipal area. The committee was to establish a checklist of criteria that are most important to the community but not to make recommendations that would preclude certain Cable Companies from entering our marketplace.

A consultant, Malarkey-Taylor was hired, specifications were prepared and eventually 14 proposals were received by the conference. The specifications dealt only in proposals for installation of cable systems from the cable companies, but did not specify the number of subscribers or franchises, nor the previous experience of the individual companies. Malarkey-Taylor submitted an evaluation recommending Cablenet, Cablevision, and Warner-Amex among the top five companies. Cablenet was the only company to offer a 5 year buy-back agreement while the others stood firm on 15 years which forced many of the other companies to withdraw from the conference. The Niles Board felt this was an important feature. With the 5 year agreement, Niles could cancel the agreement at the end of the term if Cablenet did not perform satisfactorily which influenced the Niles committee's recommendation that Cablenet should be the first choice with Cablevision the second choice. Shortly thereafter, Cablenet withdrew the 5 year, buy-back condition and returned to a 15 year agreement which eliminated the prime reason for considering Cablenet in the first place.

Letter to the Editor



The inference has been made that the board made its selection solely on the basis of a pre-payment to the Village of \$500,000, and that Niles was getting an inferior Cable system, when, in fact, a number of very important considerations which will affect the majority of the Village residents, weigh heavily in our decision.

1. Cablevision is the largest and the most established Cable Company in the Chicago suburbs, having been franchised by over 26 area communities, most recently the City of Evanston. It is now providing service in 16 Chicago suburbs and among them are Oak Park, River Forest, Homewood, Downers Grove, and Darien. In these suburbs they are serving over 14,000 subscribers' homes. Cablevision's East Coast affiliates serve over 220,000 subscribers within the New York City suburbs. Cablevision is an Illinois company with local management in place and whose personnel have successfully experienced similar market conditions over the past 10 years. On the other hand, Cablenet, a Canadian company, only has 1 operation in the United States (Southwestern Cable TV in southern Illinois) in which they purchased 51% interest.

2. Our investigations, which included phone calls and visits to municipalities which provided service by Cablevision, showed a continuing track record of meeting their commitments to these communities as well as an extensive record of providing Cable service in communities like ours.

3. Cablevision was one of three companies which qualified for the final selection by the NWMC. It was the only company which was rated by the consultants, Malarkey-Taylor, as excellent in both programming and rates (which includes a \$4.50 basic service vs. a \$5.50 basic service by Cablenet) an area which will have the greatest impact on those residents who choose Cable Television service.

Niles wins case against McDonalds
An additional McDonalds restaurant will not be built in Niles following the decision of Circuit Court Judge Arthur Dunne on Wednesday, September 2. McDonalds Corp. went to court to force Niles to issue a special use permit to construct a restaurant and five stores at Dempster St. and Grace Ave. Niles had turned down this request during a May 13 Village Board meeting in which representatives from area schools and homeowner associations turned out to voice their disapproval of the eatery being constructed on Dempster St. During the ten day court hearing Niles Village Attorney Richard Troy presented witnesses who supported his argument that the proposed 110 seat restaurant would be a nuisance to property owners to the rear of the structure and would aggravate an already congested traffic situation along Dempster St. and Greenwood Ave. McDonalds attorneys refused to commit themselves to an appeal following Dunne's decision.

HEALTH CARE FOR THE TEETH

Some people with arthritis or other conditions that limit motion may find it hard to hold a toothbrush. To overcome this, the brush handle can be attached to the hand with a wide elastic band or may be enlarged by attaching it to a sponge, styrofoam ball, or similar object. Those with limited shoulder movement might find brushing easier if the handle of the brush is lengthened by attaching a long piece of wood or plastic. Electric toothbrushes are of benefit to many.

Careful daily brushing can help remove plaque, a sticky, colorless film that forms on the teeth and contains harmful germs. If the plaque is not removed every day, it hardens into calculus (tartar), a substance that can be removed only by a dentist or dental hygienist. The buildup of plaque and tartar can lead to gum disease, in which the normally pink gums begin to redden, swell, and occasionally bleed.

Even though brushing is the most important means of removing film and food particles from the mouth, there are many places a toothbrush cannot reach. To remove germs and pieces of food from between the teeth and near the gum line, dentists recommend daily "flossing" with dental floss. A dentist or dental hygienist can instruct you in its proper use.

82 year old Nilesite wins 3 medals in Senior Olympics



No one was especially surprised when Ralph Fletcher of Niles won three first-place ribbons in the swimming competition Thursday, Aug. 20 in the Illinois Park and Recreation Association's first Six-County Senior Olympics at Northwestern University.

Fletcher, who'll be 82 years old Oct. 5, was the only one entered in his age group.

What's surprising about Fletcher, though, is that he has more stamina than a kid half his age.

Want to know how old Fletcher really is? He's so old he used to swim in the Chicago River when it was clean. He's so old that in 1921 he and Johnny Weismuller swam around Navy Pier BEFORE Weismuller became Tarzan.

To watch him swim though, with his smooth, smooth stroke and his soft flutter kick is to watch a master at work. Time - he's been swimming long distances for 65 years now - has dulled neither his spirit nor his enthusiasm nor his resolve.

Except for a brief period in the 1930s when the demands of his electrician's job kept him out of the water, Fletcher has made it a habit to swim at least a mile, every other day.

Rising at 6 a.m., he heads for

the Leaning Tower YMCA for his regular 6:30 workout, the better to keep in shape for upcoming competition.

Last year, Fletcher garnered four seconds and a third in his age group in the national AAU Masters swimming championships and also won the AAU's One Hour Swim for men 75 and over when he completed 2,600 yards in the 60 minutes of allotted time.


For all of that, says Ralph, he still can't beat the grand champion of Masters swimming, 82-year-old Clarence Ross of New Jersey.

"Except for him," says Fletcher, "I'd be the best. He's really something."

Of course, so is Ralph. "I don't feel any different than when I was 40," he says. "I can go swim a mile, and when I'm through I can still talk to you in a normal voice."

Fletcher says there's just one, small problem with being an 82-year-old long distance swimmer: At this age, "he says," I just can't seem to find any competition."

According to an analysis of the preliminary report prepared by CTCIC associates, Teleprompter received "best" ratings in 19 of the 22 categories ranked by the consultants. Metrovision was next, with 11 high ratings while Cablenet had 7. Cablevision and Centel each had 6 high ratings while Telemetrix had 5 and Omnicom had 2.

Because of the preliminary nature of the report, it was possible for more than one company to earn a "best" rating in any given category. Acknowledging that the CTCIC report is only preliminary and that other cable companies could improve their ranking when the final report is issued, Richard Ehlenfeldt, area manager for Teleprompter, said nevertheless the report "confirms what we have been saying all along". "The system we have proposed for Skokie reflects our deep commitment to the Village to provide the best possible local programming and to build an independent showcase system

However, CTCIC was quick to note that "it should be emphasized again that absolute lowest cost is not as important as the greatest diversity of services at the most reasonable cost." And, in the all-important area of average cost per subscriber for all services, CTCIC ranked Teleprompter first closely followed by Cablevision.

The CTCIC preliminary report was issued July 13 and the seven cable companies bidding for the Skokie franchise had until August 26 to reply and answer questions raised by the consultants. A final report is scheduled to be released in September and based upon it, the Skokie Village Board will begin to make the final determination of a cable company.





SECTION 3: The several sums above mentioned and designated as appropriation, which is ONE MILLION NINETY-EIGHT THOUSAND SIX HUNDRED FORTY-ONE AND NO/100THS DOLLARS (\$1,098,641.00), be and are hereby appropriated as appropriate fractional parts of the said amount of ONE MILLION NINETY-EIGHT THOUSAND SIX HUNDRED FORTY-ONE AND NO/100TH DOLLARS (\$1,098,641.00), from the proceeds of the general property tax for corporate purposes and special taxes in addition to all other library taxes as provided by law.

That all of the unexpended balance of any item or items of any general appropriation made in this Ordinance be expended in making up any insufficiency in any item in the same general appropriation and for the same general purpose of any like appropriation made by this Ordinance.

SECTION 4: The cash on hand deemed by law as current assets available for library purposes as of July 1, 1981, is \$329,107.69; the working cash fund balance as at July 1, 1981, is \$366,558.83; the estimate of cash to be received during the 1981-82 fiscal year from all sources is \$872,286.00; the estimate of the expenditures appropriated for such fiscal year is \$1,098,641.00; and the estimate operating budget for such fiscal year is \$872,286.00. The estimated cash to be expected on hand deemed by law as current assets available for library purposes at the end of such year is \$329,107.69.

SECTION 5: That the invalidity of any portion of this Ordinance or any of the items hereof shall not render invalid any other portion or item thereof which can be given effect without the valid part.

SECTION 6: That all ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance be and the same are hereby repealed.

SECTION 7: That the Board of Trustees of the Niles Public Library District has established a special reserve fund to be accumulated from the unexpended balance from the proceeds received from the library taxes levied for the year 1977 and subsequent years, said fund to be accumulated and set aside as a special reserve fund for the purposes of sites and construction and equipment of buildings for library purposes in accordance with Chapter 81, Section 1005-10 of the Illinois Revised Statutes and that said Board of Trustees shall adopt a plan or plans pursuant to the provisions of Article 5 of the Public Library District Act.

SECTION 8: That this Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.



tment computers will include programming all crimes committed in Morton Grove to help police track when and where crimes are occurring. "Hopefully it will help us to deploy officers to reduce crimes and auto accidents," explained Incledon.

Additionally, police will computerize statistics on which intersection traffic accidents occur and try and find solutions to decrease these accidents.

Morton Grove Village Treasurer Thomas Downes said the potential for police use of the computer was one of the main factors the village considered when deciding to purchase computers. Downes said the IBM computer, including six terminals, four printers and the actual computer has cost the village about \$100,000. Downes noted, "The computer will keep track of all information the police are now required to have."

Besides collecting unpaid ticket fines and village sticker bills, the police computer is being used for "man power allocation", according to Davis. The computer will tell police officials how much time officers are spending writing traffic tickets, answering calls and doing paper work. Davis and Incledon stressed, however, that these statistics would be used only to assist in spreading work more evenly between officers and not to evaluate each policeman.

The Morton Grove police look to their computer to provide assistance in all phases of police work. However, Davis is quick to point out that the computer is only a machine which will work well only if it has quality information programmed into it. Davis hopes people will not be intimidated by the computer. And summing up what this technological wizardry is all about, Incledon said, "The computer can do for us what it would take one or two people to normally do. The computer gives us the necessary information to do a better job."

4. Cablevision is constructing a dual trunk bi-directional single feeder 400 MHz system. The capacity on the trunk cable, which is the backbone of the cable system is 110 channels. The system is designed to interconnect with other municipalities and has the practical capacity for today and the flexibility for future expansion to carry programs and services that will be desired by the Village residents who subscribe to this Cable service. We were also careful to note that Cablevision has a track record of upgrading its system. For example, in Oak Park and other area communities, after construction had commenced, they made additional expenditures to increase the capacity of that system.

5. The franchise agreement with Cablevision provides channels for government, schools, businesses and the general public and allows the Village to expand the number of community channels, as use is being made of those already designated.

cent fee, not only in Chicago, but also outside the city on items sold which will be used in Chicago. The effect of this law would mean for instance, that a Niles auto dealer would be required to return one per cent of all car sales to Chicago residents to the city of Chicago. The same would apply to all Niles retailers.

The Chicago service tax, passed at the same time as the sales tax, requires all professionals performing services in Chicago to charge their customers a one per cent tax which is to be forwarded to the city. In basic terms this means that a Niles professional, whether he is a plumber, carpenter, lawyer or doctor, must collect an additional one per cent tax from his Chicago customers and send it to the city of Chicago.

The legality of the Chicago service tax is currently being studied by the Illinois Supreme Court. However, while waiting for a decision Chicago is still collecting the one per cent tax from professionals.

Blase said during the Tuesday night meeting that two of Niles' largest retailers, Sears Roebuck and Co. and J.C. Penney, both in Golf Mill Shopping Center, have indicated they will collect the one per cent tax on merchandise delivered into Chicago.

A Sears official, who wished to remain anonymous, recently told The Bugle that Sears' decision to pay the tax was based upon politics rather than law. The Sears official said Sears would collect the tax in its suburban stores because it wanted to avoid any possible harassment by Chicago officials at its numerous city stores.

Niles businesses received letters with accompanying registration forms from the City of Chicago at the beginning of August instructing them they would have to begin collecting the sales tax from Chicago residents purchasing merchandise in Niles. In an August 6 letter to local merchants, Blase urged businesses not to participate in the program until the courts had decided on their legality.

Also Blase warned Niles merchants not to fill out the registration forms fearing they could "be subject to harassment and/or other involvement with the City of Chicago."

Chicago hopes to collect \$110 million annually from the service tax and \$95 million annually from the sales tax, according to Annette Ptak, Deputy Comptroller for Chicago.

Labeling the Chicago sales tax a "tremendous burden on suburban merchants", Blase said he felt Niles would win the suit because the Chicago tax is not enforceable in the suburbs. Additionally, Blase said if every home-rule municipality in Illinois followed Chicago's example, each municipality could impose a sales tax upon businesses selling merchandise within their municipality.

In other business, the village board approved a zoning change petition by the Millionaire's Club restaurant in Golf Mill shopping center to construct a dinner-playhouse. Originally requested by restaurant officials last spring, Niles zoning officials delayed approval of the playhouse until details could be worked out regarding aisles and exits in the building.

Also the Niles Village Board presented a plaque to retiring public works employee Ed Clark. Clark, whose father was Mayor of Niles in the 1930's, had worked for

the public works department for over 17 years.

Representatives of Cablevision of Chicago, recently awarded Niles cable television franchise, presented the village a check for \$350,000 and a letter finalizing the agreement. The money represented the first payment in what will eventually be \$500,000 delivered to the village in "up-front money" in exchange for the franchise.

Blase noted Niles had worked out "the greatest (cable) package anywhere in the suburbs," with Cablevision.

receive a median salary of about \$20,000 per year. Most of the personnel earning this salary have five or more years of college. Salaries for 12 administrators other than Bond were also approved with a median of about \$38,000.

Board members, although scheduled to ratify a tentative contract with the teachers, hesitated because a contract with specific language was not yet available. Barbara Korb, vice-president of EMEA and a union negotiator, suggested school board members ratify the tentative contract as the teachers had done August 31. Board members complied with her request to indicate "indefinite" pending presentation of the formal contract.

The school district and teachers reached an agreement in eight negotiating sessions for a salary increase of 20.2% for the total two-year contract.

Several parents again complained of the long and hazardous route children must take to Twin school in order to bypass a stockade fence place by Courtland Square Condominiums on the east side of Western avenue north of Golf road.

At a former meeting, the school administration was directed to contact Courtland Square in order to obtain permission for installation of a gate and lock in the fence. James Bowen, business manager, said the condominium association would discuss the matter at their next meeting.

Board members took the unusual step of approving a motion defeated at a former meeting. The motion would provide for \$1,500 subsidies to six teaching team coordinators at Gemini school for the 1981-82 school year. Donald Huebner, principal of Gemini, said the team coordinators would be "unifying" this first year of the combined Apollo and Gemini junior high school student bodies.

Apollo was closed in one of the district's austerity measures. Voting against the expenditure were board members Ann Sostrin, Joan Futterman and Larry Solomon. Richard Smith, board president, voted against the measure once but not the second time. Norman Padnos and Don Weiss also voted Tuesday in favor of the measure.

Weiss was absent during the first vote. During a public participation session, a parent voiced her concerns over the high busing fee, about \$90. She said her children live over a mile from school and she is the sole provider. She suggested there be some allowance for persons not able to afford the fees.

Board members discussed lease agreements between the school and park districts. The Niles Park board maintains the grounds or some grounds around three of the district schools. At a committee meeting, park board members discussed rental of a room in Oak school in return for this work. Philip Deckowitz, school board member, said he thought the lease did call for "reciprocity". Deckowitz said he would be in favor of letting the Park Board use one room in Oak school.

At a special board meeting August 31, board members approved the proposal from Northern Trust Company, Stern Brothers and Company and Clayton Brown and Associates, Inc. for a bond sale of about \$5,000,000 with an average in-

The major difference between systems in the 2 communities is Evanston will have more time for programming. According to the Cablevision people, the 2 communities have different needs. Evanston has Northwestern University which it implies will require wider cable services than Niles.

We assumed the different needs of the communities means different equipment and studios will serve Niles and Evanston.

The complexities surrounding the entire cable TV subject obscures the many facets to understanding the subject. In our office Marcheschi and Ottow explained how they went out of town and investigated on the spot cable TV operations in other communities. They devoted more than 2 years to studying the subject. And they are far from experts. In our discussion with them, they disagreed with each other as to the requisites needed in acquiring a 3% return from fees versus a 5% return, which Niles will be eligible for. It manifested how complicated the subject is and how difficult it is to make a sound judgment in assessing cable TV's potential.

Cablenet was the first choice of 17 northwest communities that joined with Niles in studying companies. Cablevision, which Niles chose, was their 3rd choice. Niles passed a March resolution, which favored Cablenet. Just a few weeks ago Cablevision came up with \$500,000 upfront money which switched Niles into their network.

According to Marcheschi, after they switched, Cablenet offered \$800,000 for use in the installation of a tornado warning system.

The strongest argument in Niles' favor is there are 16 active Cablevision franchises in this area while Cablenet has only one, down south in Edwardsville. Marcheschi and Ottow also contend Cablenet was the first choice by the 17 communities, largely because they were willing to limit their franchise contract to a 5 year period. Subsequently, they changed it to 15 years, which Marcheschi contended was a consideration in changing Niles board's collective mind away from Cablenet, their first choice.

As we attempt to weed out all the chaff, we're trying to seek key points which should be the significant ones in reaching a sensible choice.

According to the cable people, Niles upfront money will be deducted from future revenues based on a 3% figure. Niles could be eligible for a 5% revenue return. This point seems worth exploring and one on which Ottow and Marcheschi disagreed. We were told in order to be eligible for the 5% fee, the money received must be used in the cable TV field. It is only our assumption, but if Niles takes the advance \$500,000 and places it in its general fund, it may not be eligible for the 5% fee return but will only receive 3%. The point should be clarified.

The studio, facilities, equipment and services should be the other areas to be compared. We believe this is where there can be a vast difference between companies. Less facilities should limit services. And less equipment and other services will decrease the quality of cable services to the community.

Ottow was a bit disturbed as he walked from our office. He told us we're out to sell more newspapers. He was angry. But we still have the echo in our ears from Friday, when Cablevision's own representative said it is a "trick" to hand out money upfront, it is not good business, and it is depriving future village boards of revenue.
