their goals and values and how these relate to substance abuse. We want them to consider peer pressure and urge them to make their own decisions," says Selway. "We also want them to seek treatment when appropriate."

There is no typical profile for a student enrolled in Project Rescue according to Selway. "Any student in the high school may become involved with alcohol or drugs. It is better to err on the side of caution if you think your child is experimenting. A teenager rarely gets caught the first time he tries," says Selway.

According to Selway, it is equally important that parents remember that every child who experiments with drugs or alcohol is not necessarily addicted to them. Only about half the students who are enrolled in Project Rescue are referred for further evaluation at a substance abuse treatment center. Other recommendations are made as appropriate.

should be completed because the resultant operating savings would bode well for its customers when they went "on-line." In the long run, the anticipated energy cost savings would work to the benefit of the area and its economy. Edison is a closely regulated Company in everything it does.

This regulation is the offset to the "monopoly" aspect of utility operations cited by the article.

The Company's activities are regulated by a myriad of State and Federal agencies, in some cases with resident auditors and inspectors on our properties. Included are the ICC, FERC, NRC. State and Federal EPA's, Army Corps of Engineers, SEC, OSHA, EEOC, NLRB, etc. etc. Thus, even if we were so inclined, there's little we could do to "play games" with our costs and related money requirements. But, because we provide an essential service, we can't be allowed to "fall apart" in either service or availability. The public interest in this is apparent.

Many of the costs we incur are beyond our control with a possible partial exception. Fuel costs account for over a third of our expenses. In part, we went into the nuclear arena in order to get some control of these costs, yet as events testify our path here has not been an easy one although the fuel and total KWH cost savings from nuclear have been and are significant.

As the largest tax payer in Illinois, taxes account for over onefourth our costs. Today for every dollar of added revenue we require, we must ask for two dollars, the other dollar goes for taxes. In effect, we are a tax collector for government. But the onus falls on us.

Operating and maintenance, the costs of keeping our 11,000 square mile system going and of running 13 large central generating plants account for only another one-fourth of our

- So given the fact that only one-fourth of our operation costs are directly controllable, we don't feel we've done too bad a job considering the times we've all lived through. In fact, the cost of electricity here has risen much more slowly than the costs of oil gasoline and natural gas. And, in our area it has risen much slower than has the cost of electricity for the United States, as a whole. When our new plants are "on-line" in a few years, and other areas of the country play "catch-up" with higher costs facilities we will look even better.

man who acts in this matter part-time. His job is to explain our views to legislators and this is a proper activity in view of the nature of what we do. It's true we pay a \$3 dividend. But, we pay only enough so that we can competitively market our securities to finance our construction program. No market, no funds! The \$3 dividend can be related to a number of bases depending upon what one is

trying to say. People who bought our stock in the early '70's paid well over \$40 a share. Their return? 7.5% People who bought our stock a few months ago, paid \$29 a share. the pre-inflationary early '70's was probably worth in excess of over \$80 in terms of 1984 - dollars, so in value returned the 1971 investor is realizing less than 4% on his investment and, in fact, has watched his savings melt away. Nonetheless, the generating plants he financed are serving our customers today very well and have saved our customers hundreds of millions of dollars in reduced fuel costs which are recovered through billings. If the allusion was to the Byron plant, it is not yet in service so it can hardly be called "shuttered." However, we fully expect it will be in service by year-end. As you might already know, the NRC staff did not agree with the decision of the ASLB. In any event, the latter is a recommendatory body only and it based its decision upon incomplete data. That decision is under appeal to a higher level board at this time and we fully expect approval of our operating license request. I don't believe Edison has ever been offended by justified

criticism of its actions or positions. We'll take our "knocks" with the next man. And, we are fully cognizant of our high profile in the community and that it's difficult to overlook us. However, like anyone else, we bridle at aspersions concerning the motives and morality behind what we're trying to do.

We've saved this area for almost 100 years. We're a local Company, controlled by a local management with an extremely high level of local ownership in terms of our security holders. How foolish we would be to violate the relationships implicit in those facts for any perceived short term gain or interest! As a Company of the kind we are, if we structured an adver-

tising program to reach certain of the publics we serve, we would not "bite-our-nose-to-spite-our-face" by denying ourselves access to any of such publics reached by "The Bugle" or any other available media outlet. If we reacted, as suggested to much of the treatment we've received from the metro and local press, we would not be doing any advertising at all. In fact, during a period of low earnings a few years ago when we were paying dividends our of capital, i.e., out of our bone and muscle, we did have budgetary

restraints on our advertising program. In the matter of the price-squeeze on low and fixed income people, we are well aware of the problem. In fact, we implemented an aid program last year designed to help such people on an interim basis; that is, until government stepped in with a permanent plan. We have tried to encourage state government to divert monies from its utility tax revenues for this purpose. As a regulated utility we are not allowed to discriminate between and among our customers with our charges. And, I don't think anyone would want us to add people in the numbers needed to administer any assistance program. The costs would have to be recovered through rate hikes. Government has agencies, in being, which are staffed and equipped to do this kind of thing and we think they should do it.

I have no recollection of the pole-in-the-walk matter, so I can't fairly comment upon it. On the face of it; however, if the situation was described. I have to agree that we were foolish to have made moment of it. And, I do apologize for it. I've enclosed some charts which will serve to put in perspec-

tive some of what I've commented upon above. If you've any questions, I'll be happy to address them. On another tack, you and Bob missed an interesting visit to the Zion Nuclear Station last Friday. 
