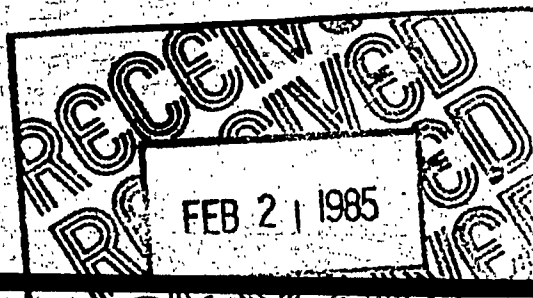

## Glenview Library voices opposition to annexation plans

In more controversy surrounding former annexation plans by the Niles Library District, the Glenview Library has written the District that it also "opposes the annexation".

A letter to that effect was presented to Niles Library members at a Feb. 13 meeting in the main library, 6960 Oakton.

The letter from the Glenview library read, in part, that it "opposes the annexation by the Niles Public Library District because it would financially impair the Glenview Public Library by eliminating current revenues from the residents of the area to be annexed while causing the library to provide extra library

service to Niles cardholders." The Glenview library is probably referring to Niles library cards issued by the District to residents not living in an area served by either a municipal or district library system. For one year, until June, library cards for those residents

## Faulty extension cord causes Niles home fire

A fire reportedly caused by a faulty extension cord severely damaged a Niles house on Tuesday, Feb. 12.

Niles fire officials were notified at 2:15 p.m. that a fire had broken out in the home of Vincent Heins, 6933 Oakton ct.

Arriving on the scene with six fire vehicles, firemen found an

upstairs bedroom and hallway engulfed in flames.

While the fire was put out by 2:31 p.m., fire and smoke did extensive damage to the home.

An initial investigation of the cause of the fire pointed to an extension cord which apparently melted and caused the blaze.

## Ready Park computers for Open House

The Niles Park District will present its newly installed computer system to area residents during a Saturday, March 16 open house at 2 p.m.

Announcing plans for the Open House during the Tuesday night Niles Park Board meeting, it was explained that the computer system will take over many services which previously were done on the outside, according to Park Board President Mary Marusek.

Payroll will be completed on the computer as will revenues taken in and expenditures.

Financial statements will be handled by the computer and summer program registration will also be done.

Marusek noted she expects a \$5,000 to \$8,000 savings just by the park district doing its own payroll.

The most important issue in Niles upcoming election concerns the omnipresence of Nick Blase in all phases of Niles government.

If you're one of the few people who've attended a Niles village board meeting in recent years you would see a cadence to the meeting which muffles much discussion. The meetings seldom last more than an hour and are so routine there are few discussions of any consequence. The meetings sound like they have been written, scored and produced long before meeting time. It's a plastic hour with teflon trustees routinely showing up to acquire the few bucks they make for meeting attendance.

Recently, there was an exception to the usual non-debatable meetings. Number one son, Bob Besser, covered a recent meeting in which Niles trustees Marcheschi and Murphy conducted a discussion with a builder which was most impressive. The builder had previously come before the board and said he had his loan money in hand. But subsequently, the builder was asking for extension from the board.

Marcheschi, whose past background includes working in building construction, and Murphy, an executive with a in-

## Court returns TIP candidates to ballot

A Cook County Circuit Court judge has ordered the nine Maine Township Improvement Party (TIP) candidates recently ruled ineligible back onto the April ballot.

In a ruling handed down on Thursday, Feb. 14, Judge Joseph Schneider said the nine candidates could fill the vacancies on their party slate.

This overturned action by the Maine Township electoral board on Feb. 1 which ruled that the nine TIP candidates had incorrectly filed their statements of economic interest and were, thus, ineligible to run in the April township election.

Maine Township officials had claimed Illinois law demanded the statements of economic in-

## Reduced Social Security benefits

The amount of each Social Security retirement check is permanently reduced if a person elects to retire under Social Security before 65, Dennis Randall, acting branch manager in Des Plaines, said recently.

Payments are also reduced if a spouse or a widow or widower begins receiving payments before 65.

The amount of the reduction depends on the number of months the person receives checks before reaching 65. Those who start getting checks earlier will realize about the same total amount over the years; however, the amount of each check will be smaller because of the longer period during which they will be received.

## Info on delinquent Real Estate Tax Bills

Roy H. Bergquist, Maine Township Assessor, said today that many Maine Township residents have not received their 1984 1st Installment Real Estate Tax bill. These bills are due and payable on March 1. Assessor Bergquist's office is receiving approximately 50 inquiries per day-Duplicate tax bills can be obtained at the Cook County Collector's Office, 118 N. Clark st., Chicago Illinois or by calling the Collector's office 443-5100 and requesting a duplicate Tax bill to be mailed to you.

After checking with the Collector's office Assessor Bergquist suggested the Tax payors who do not receive the original or duplicate Real Estate bill in time to pay it, should send their check payable to the Cook County Collector, 118 N. Clark Street,

Chicago, Illinois 60602.

You must print on your check your Property Index Number and that it is for 1st Installment of 1984 Real Estate Taxes. Assessor Bergquist also suggests you include a short note explaining your payment and the lack of a bill.

Remember—Not receiving a tax bill does not relieve you of your liability to pay your real estate tax—Penalty and interest may be assessed against you for late payment.

## Available Circuit Breaker Forms

State Rep. Ralph C. Capparelli (D-13) today announced that he will make available to senior citizens and disabled persons the forms necessary for filing claims under the "circuit breaker" property tax relief program for 1984. "All persons over 65 and disabled people unable to work are eligible for possible rebates on property taxes and rent payable this year," Capparelli said.

The state expects to pay over \$80 million to elderly and disabled homeowners and renters under the "circuit breaker" legislation that I originally co-sponsored in 1972. Last year, rebates to qualified senior citizens and disabled persons averaged \$500," he said.

Claim forms are available, Capparelli said, at 6702 Northwest Highway, which is his district office. Office hours for pickup of these forms are Monday, Wednesday and Friday from 10 a.m. to 2 p.m. and Saturday from 10 a.m. until noon. Circuit breaker forms will be mailed to interested persons by calling the ward office at 775-5775 during office hours or by writing to Rep. Ralph C. Capparelli at his district office.

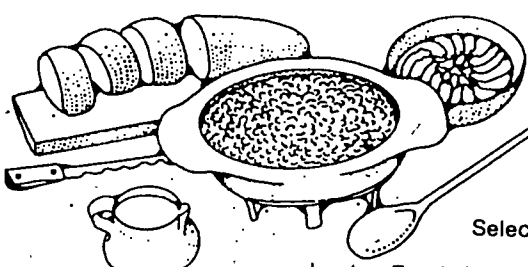

## Center of Concern hearing program

A hearing problem is a subtle one in that frequently others are aware of it before the afflicted one is. The Center of Concern is now offering the services of Beth Hoffman, an audiologist, who will be available for information and counseling about this problem.

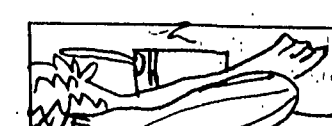

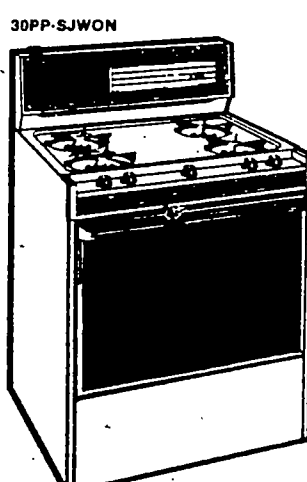

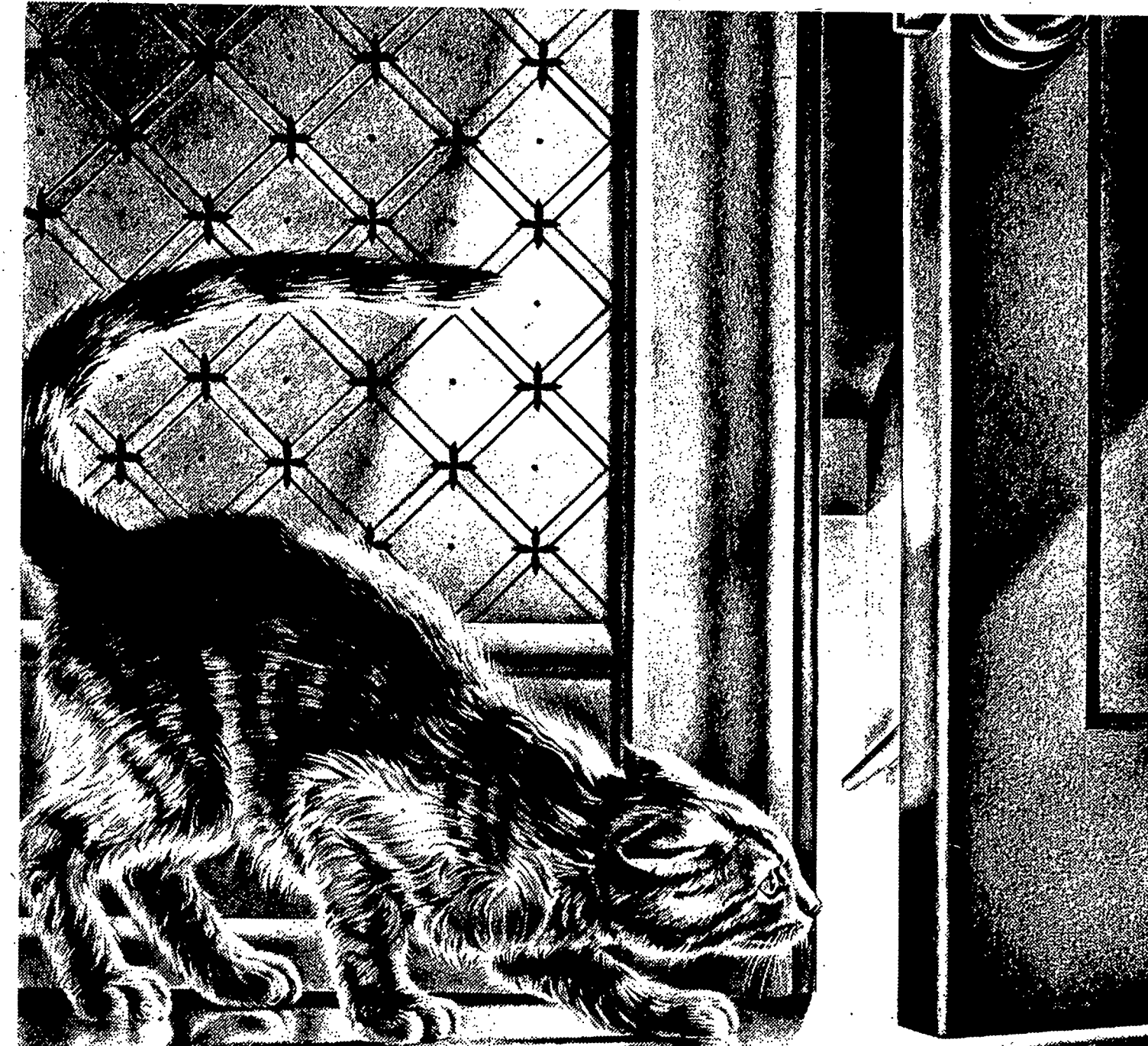

### Roosevelt graduate beats impossible odds

The word "impossible" just isn't in Lynn Cain's vocabulary. The 30-year-old Niles woman proved that in January by marching across Chicago's Auditorium Theatre stage to receive her MBA degree from Roosevelt University.

Cain, a 1976 University of Illinois graduate and research associate at Baxter Travenol Laboratories, Morton Grove, finished her master's program at Roosevelt despite the interruption of five brain surgeries, a crippling stroke and a three-week coma.

When she awoke from the coma, Cain was partially paralyzed and left with impaired

vision. Reading simple elementary primers was a challenge for the graduate student.

Determined not to give up, Cain underwent six months of physical therapy, reading therapy and vision therapy before she could return to work. By Fall 1983, she was back at Roosevelt to finish her remaining four courses for her MBA.

"I wanted to prove that I still could be trusted in a responsible business position; that a stroke doesn't have to incapacitate its victim," she said.

Roosevelt University degree in hand, and a satisfying career ahead, this persistent young woman has made her point.

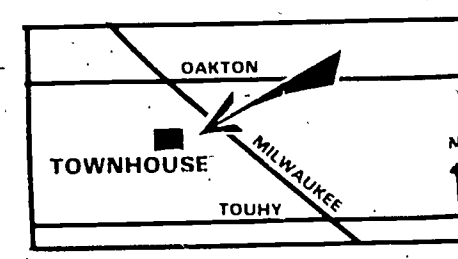

## HOSPITAL NEWS

### New mammography equipment at Lutheran General Hospital

Lutheran General Hospital, Park Ridge, Illinois, recently installed new state-of-the-art mammography equipment. Mammography is an x-ray process that can detect cancer in the breast at an early stage, even cancer that is too small to feel.

"Breast cancer is one of the most common forms of cancer. It strikes one out of every 11 women," says Nicholas Kinnas, M.D., Radiology, Lutheran General Hospital. "Early detection is a significant factor in the success of treatment."

The new mammography equipment is called Senographe 500T. It is designed to provide better mammographic imaging capability that can locate cancer the size of a freckle. It also is safe as it involves the lowest dose of radiation.

"Mammography allows us to evaluate a palpable mass to see if it is malignant," says Dr. Kinnas. "Mammography is safe and the chances of this type of x-ray producing cancer in the breast is practically non-existent and to date is only a theoretical possibility." Dr. Kinnas adds that it is more dangerous to smoke one-half of a cigarette or to drive a car for 30 miles than it is to have a mammogram.

Mammograms increase survival rates tremendously. "A mammography exam, when used in conjunction with a physical examination and a self examination, results in the highest chance of cure," says Dr. Kinnas.

The American Cancer Society recommends the following guidelines for mammograms.

- An initial mammogram at the age of 35.

- A mammogram every year or two between the ages of 40 and 50.

- An annual mammogram over the age of 50.

insurance firm, unthreaded the rather weak testimony of the builder. They created a colloquy between the builder and themselves which was an example of the democratic process operating at its best. While the builder was using fancy footwork to get around the issues, Niles' two trustees persisted in keeping the developer on track, eventually telling him to come back to the board when he was ready for final approval.

The thirty minute discussion was the mark of intelligent people confronting a petitioner who was not on sound ground. It was what public meetings should be all about. It was one of the few times in recent years when Blase gave the trustees free rein to discuss a matter in an unfettered fashion.

Contrast the aforementioned meeting with another builder confrontation many months ago. Developer Ray Adreani, friend of the boys at the hall, agreed with local residents to build only eight homes on the property at Harlem and Oakton Court. He had originally sought nine permits but Blase told Ray to go in the back room and resolve the matter with local residents. He agreed to build eight homes. At the next meeting Ray's son showed up and nullified the agreement suggesting they needed nine homes on the property. Despite Blase and the trustees supporting the previous compromise, they turned their backs on the

residents and allowed the builder to go back on his agreed word, and build on nine lots.

In this second case there was no discussion. Adreani, friend of the officials, and another "one of the boys", was able to renege on his agreement. Neither Blase nor any of the trustees had any discussion. They routinely went along with the builder.

The contrast in confronting the two developers was startling. In the case of the first developer, Blase allowed the trustees free rein and Marcheschi and Murphy showed the stuff they are made of. But when Adreani's son appeared before them there was silence. The residents were not represented by their public officials. The builder, "one of the boys," was. And he doesn't even live in town.

Carol Panek will be looking for issues in the coming weeks. The omnipresence of Nick Blase in every phase of Niles government, subjugating the other officials to secondary roles, is an important issue.

As individuals, Niles trustees are bright articulate people. But when they're in the presence of Niles Mayor, they become shadows of their true selves. It's demeaning to themselves. And it demeans the community which is not getting the representation it deserves, nor which it asked for when it went to the polls.

interested in obtaining one will be paid for by funds issued as a grant entitled "Project Plus" to the District.

In a related matter, representatives of the Glenview library meeting with other library personnel at the North Suburban Library System (NSLS) said they would be spending \$200,000 more because of reciprocal borrowing with Niles library cards.

Reciprocal borrowing is lending to a library patron within the System with any System library card and return of the book to the originating library by the local library. Reciprocal borrowing exists with other library systems within the State but the book must be returned to the lending library by the library patron.

Also at the NSLS meeting, Glenview library representatives asked the System for \$2 a book under the reciprocal borrowing plan. Glenview's representatives claimed the library will be lending out more books because of "Project Plus" in Niles.

NSLS now pays its member libraries about 27¢ a book for each book they lend out over and above those borrowed from other libraries. Glenview's request for \$2 a book was not granted, said Harry Pestine, Niles library board president and NSLS representative.

Also, the Niles Library continues to receive unfavorable correspondence from some residents in unincorporated Glenview regarding "Project Plus."

Those persons may have "Project Plus" funds and issuing of library cards under the project confused with annexation. Plans for annexation, at this time, have been dropped.

Proposed deferred compensation plans may be made available to library employees through three companies: Equitable Insurance Co., ICMA and New York Life.

The plans will replace funds issued to employees toward an Individual Retirement Account (IRA). The change in deferred compensation plans is taking place mainly because of a report to board members that some employees cashed checks intended for IRA accounts. At a former meeting, the board attorney warned board members money not replaced by employees will be considered income and the library will be held responsible for withholding taxes.

Finance committee chairman, Frank Biga, said he wants to provide board members with a "better picture of the library's financial condition" and "investments strategy" to increase library income. Biga said personnel, materials and books are competing for funds. Also, Biga said the study will be part of the budget process.

Senator Simon," said Aderman. She pointed out that on many other important matters of concern, not all the legislators are in accord, although they all took the position that the deficit is a serious problem.

"Going to Washington as a representative is always so exciting, so hopeful, but by the time you're done, you want to cry," revealed Aderman.

"The President's budget is another sad thing," she stated. "President Reagan is freezing all social programs, including education, but we feel that the education of our children is our first line of defense - so this is a terrible happening," Aderman concluded.

President Sheldon Marcus announced a much-anticipated event at Niles West - the guest appearance on Wednesday night, March 6, of Ron Mages, popular news anchor person of Channel 5.

Mages will talk on "Alcohol and Drugs," subjects close to his heart. In addition, there will be an Expo-type fair sponsored by medical personnel, with interesting exhibits to visit. Parents of all children in the community are urged to attend and ask questions, because communication is the basic key necessary to help tackle the problems confronting young people as a result of using alcohol and drugs.

In the Superintendent's report, Dr. James Erickson reported that the Illinois Supreme Court refused to hear the case of deannation between Glenbrook School District 34 and School District 219. The ruling of the Appellate Court stands, which means that the case has to be returned to the Regional Board of Trustees for action. Dr. Erickson also reported that both Niles North and Niles West were visited by representatives of the County, who made the following comment after a tour of both schools: "Your buildings look good and we are impressed by the orderliness of the pupils."

**Niles fire...**  
Fire Inspector Ed Sosnowski said it appeared an iron had been plugged into an inexpensive extension cord which was being used in the upstairs bedroom where the fire started. When an electric fuse had to be replaced, the resident who was ironing went into the basement to the fuse box. After putting in a new fuse they reported hearing smoke alarms going off upstairs. By the time she returned to the room where the iron had been plugged in, the curtains and a mattress were in flames.

Sosnowski said the resident and her daughter tried calling the fire department but the fire had burned through their phone lines. Running into the street a neighbor saw what had happened and called the fire department.

Sosnowski said the extension cord attached to the iron had apparently melted causing the electrical fire.

He noted a cord attached to an appliance such as an iron must be strong enough to handle the relatively large amount of electricity pulled through it to prevent overheating.

Damage to the home was placed at \$15,000. Additionally, the residents have had to move out of the home until it is repaired.

Niles Firemen received assistance from the Morton Grove Fire Department. No firemen were reported injured while fighting the fire.

Mr. John Nix, Director of Buildings and Grounds, gave a brief history of Oakton Community College tenancy of the 219 building. Negotiations are in progress with O.C.C. to extend the lease of the eastern campus building through 1992. The Board was unanimously in favor of that extension.

There next ensued discussion of the Hatch amendment, which revolved about the unwillingness of supporters of this amendment, to permit the intelligent discussion under capable direction in the schools, of these topics: drugs and sex; theory of evolution; and religion. The feeling was that the Board of Education should remove the Hatch regulation.

It was announced that the Niles Township Prom and Graduation Committees would like to send a response coupon/mailer to the parents of graduates, now that Prom night and graduation are approaching. It was suggested that a one-dollar donation be asked of parents whose names will be listed as supporters of a non-alcoholic Prom. The monies collected will go toward the payment of newspaper advertisements and thus offset the cost of this project.

Parents are urged to come to see what is being done at the schools, especially the week of March 3 through March 9. It is hoped that a good attendance will be on hand Wednesday night, March 6, when Ron Mages will appear at Niles West, so that fathers and mothers will be getting involved in this very important drive to combat alcoholism and the use of drugs in both Niles Township High Schools.

There followed comments by Jonathan Minkus, who said what a joy it was for him to travel to Lake Forest to watch the excitement of Niles North winning, an achievement of delight and recognition for sports lovers in our community and elsewhere.

James Dusbabon of Skokie, chairman of Loyola Academy's Science Department announced that, "the computer is here to stay in my classes."
