

Two television commercials sponsored by the Village of Niles are warning consumers to stay away from on-line sales and stick to shopping at stores located in the village.

The reason? Dangerous hackers and thieves eager to defraud an unsuspecting public are preying on innocent on-line shoppers.

In one commercial, which has the no-nonsense look of a public service announcement, viewers are informed by an actress that "hackers have broken into Web sites for the Pentagon and FBI."

The actress, who is dressed in business attire and sits in a room not unlike a law office giving the impression that she is a lawyer or advocate of some kind, urges viewers to ask themselves if they want to take a chance "at becoming a fraud victim?"

The second commercial interviews people at the Golf Mill Mall, who all state what a great place it is to shop.

While emphasizing the hazards of on-line shopping, the advertising campaign barely mentions the true reason behind the

## Police issue warrant for 33 year-old Chicago man; relatives say suspect fled to Philippines

# Suburban rape suspect flees country

A name and a face can finally be connected to the elusive suspect who has been wanted for a series of home invasions and attacks on Asian women since April. Unfortunately, police still don't have him in custody.

Chicago resident Mark Anthony Lewis, 33, is believed to have fled to Philippines on July 20, following the most recent attack on an Arlington Heights woman, the day before.

It is likely due to this woman's observations that Lewis has been named as a suspect.

After fighting off a man who came to her apartment posing as an immigration officer, the woman told police that she saw him drive away in a green sedan with a license plate containing

the letter C and the numbers 7, 8, and 2, though she was unsure of the numbers' sequence.

While other victims have told police of their attacker driving off in a green Pontiac Grand Prix, this is the first time that a

## Concordia University to host 24th Annual Early Childhood Conference

The keynote speaker, acclaimed musician and performer Jim Gail of Oak Park, will discuss "Sharing Playful Interactions: Music and Drama Play for All Young Children." A teacher of young children, Gail has for many years offered weekly workshops for children and families

through a variety of agencies in the Chicago area.

## Credit card fees will continue to rise

Recent reports of rising credit card fees point out the need for people to read and understand their credit card agreements and monthly statements. Fees range from just a few dollars for a small cash advance to more than \$30 for returned checks.

"Most people are concerned only with making their minimum monthly payment," said Steve Rhode, president of Myvesta.org, a nonprofit financial solutions organization. "As long as they can afford the amount that's in the little box at the bottom, they don't pay attention to details."

Rhode goes on to say, "It's not unusual for us to see people who are paying more than \$500 a month for late payment, over-limit, returned check and cash advance fees. For example, last month we assisted a client who was paying \$870 a month in late and over-limit fees. That's someone who needs emergency help."

When reviewing new client cases, Myvesta.org finds people are currently paying an average of \$60 in total monthly penalty fees to credit card companies. The most common are the late and over-limit fees, which typically run \$29 each.

"Late fees can be dangerous," Rhode said. "If a person is only

making the minimum payment, one late fee can add an extra 20 months and \$355 in interest to the debt." This example is based on the average credit card debt of \$1,800 and a late fee of \$29.

"All fees aren't necessarily bad," Rhode said. "If you end up paying an annual fee make sure that you get value for it, such as 24-hour access to customer service, rebates and/or bonus points. Good service can be worth the extra expense."

Myvesta.org offers the following primer to help people understand the various fees and how they are calculated:

**Late Fees** -- Get your payments in on time. In most cases, you will pay a late fee if your payment arrives just one minute past the time due. Banks have extended their mail processing hours so that payments will be posted the day they are received - a benefit to late mailers. Always mail your payment as soon as possible. It is foolish to wait until the last minute.

**Over-Limit Fees** -- Know your credit limit. Credit card issuers establish your credit limit based on your ability to repay charges. If you exceed the limit, the issuer sees you as a bigger risk and will charge you a fee each month that you exceed the

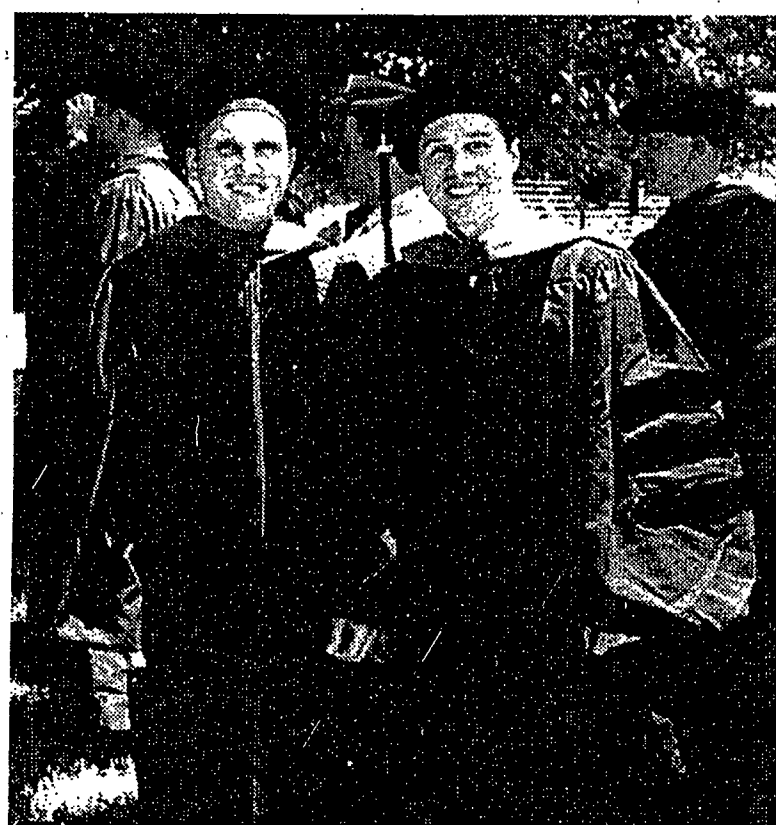

## 'Condominium Development is Smart Community Planning'

Many of us have heard about "Smart Growth" and the benefits derived from this type of community growth management. A term that has grown from the anti-sprawl development movement, Smart Growth seeks to direct new development to areas where adequate infrastructure and commercial development is already in place. Strategically placed condominiums, a type of multifamily housing, is a form of "Smart Growth" planning.

The benefits of condominium housing range from quality of life issues, local economic benefits, reduced municipal service costs, reduction of traffic congestion and reduced impact on schools.

Condominiums are generally more affordable and require less maintenance than single-family homes allowing for an aging community to retain residents. Condominium housing can provide freedom from the responsibility of home maintenance and repair affiliated with single-family homes, thus freeing up more time and disposable income for other activities, recreational or leisure pursuits.

A municipality also benefits from condominium construction. These types of low-impact homes reduce local government's capital land operating costs. A study shows that single family homes at

3 units per acre require \$2,361 in public services annually per unit, while multifamily units at 30 units per acre require only \$1,647 per unit in public service expenditures. This type of housing also places fewer demands on municipal water systems, due to several factors, such as smaller household sizes and fewer bathrooms.

Typically, because condominiums are located in convenient locations, shopping, transit, people who live there generally don't drive, putting less traffic on local roadways. Studies show that condominium housing reduces traffic congestion as residents of condominium homes own fewer cars and generate fewer motor vehicle trips. Fewer motor vehicle trips reduce the need for more roads, maintenance of existing roads and environmental impacts.

Educationally speaking, residents of condominiums also generate fewer students for the local school system than single-family residents. Typically, 100 single-family homes generate an average of 55.6 school-aged children, whereas 100 multifamily units may generate 36.1 school-aged children. Condominiums have been known to generate even fewer school-aged children.

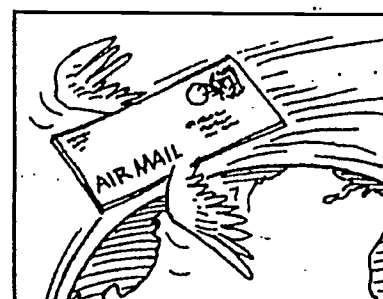
Condos produce high taxes for schools while providing very few children; e.g., the Renaissance -

420 units - 12 children.

### An inoculation against certain reading difficulties

"Teaching Cued Speech to Hearing Children - An Inoculation Against Reading Difficulties" will be one of several presentations for parents and teachers offered at "Camp ChiCueGo," sponsored by Alternatives in Education for the Hearing Impaired (AEHI) on the Campus of Dominican University in River Forest, August 4-7. Presenters are Dr. Susan Kromelow, a school psychologist, and Ms. Sue Mies, a second grade

teacher at Hynes School in Morton Grove. Last year Kromelow and Mies developed an interdisciplinary Task Force on Phonological Awareness Curriculum at Hynes to assist teachers in developing a repertoire of teaching activities to help children develop phonological awareness skills as a basis for learning to read. Approximately one third of American children entering kindergarten lack adequate phonological awareness, or the con-

scious awareness that words are made up of sounds. Typically these children do not understand the concept of rhyming or of words having beginning and ending sounds. Even if they can memorize the alphabet letters and their corresponding sounds, when shown pictures of a sock, a saw and a goat and asked which words start with the "sss" sound, they do not know. The good news is that for most children this ability can be taught through age-appropriate, entertaining activities focusing on auditory/perceptual activities such as breaking down words into their individual sounds. However, some children find this skill particularly difficult. The cause is not clear. The hearing of these children is intact, as is their spoken language, but this difficulty in perceiving the sequencing of sounds within words affects their ability to learn to read and spell. To bolster the auditory/perceptual skills of these children, educators have developed multi-sensory programs incorporating tactile and visual input, such as having the children use mirrors to learn how and where word sounds are made.

Kromelow was researching remedial reading methodologies when she learned about Cued Speech through a friend whose child is hearing impaired. The mother, Sandra Moseick of Riverwoods, IL explained that Cued Speech is a set of visual "cues" made near the face with one hand while speaking normally, which effectively "makes the sounds of speech visible." Kromelow immediately recognized the potential for Cued Speech as a visual method with enormous potential for helping children compensate for auditory perceptual problems. Kromelow and Mies are not specialists in Deaf Education. However, their work with hearing children has led them to hypothesize that cueing can be an effective method for teaching phonological awareness to all children. Teaching mainstream kindergarteners to cue may help minimize reading difficulties in

the hearing population while facilitating the inclusion of hearing impaired children in the mainstream -- truly a win-win situation for all concerned. Kromelow is currently developing research protocols to explore the effectiveness of this approach.

Camp ChiCueGo will attract families of deaf children from as far as California and North Dakota. Programming will offer instruction in Cued Speech and other presentations for parents and teachers about dealing with deafness in the home and the classroom. Kromelow and Mies' presentation will be held at 1 p.m. on Saturday, August 5th. ### Survey shows effective skin care helps combat unsightly rosacea

Effective skin care can significantly improve the appearance of the estimated 13 million Americans who suffer from rosacea, an acne-like facial disorder now becoming increasingly widespread as the populous baby boom generation enters the most susceptible ages.

In a new survey of 1,273 rosacea sufferers, conducted by the National Rosacea Society and published in Rosacea Review, more than 91 percent said they had modified their skin-care procedures to help control the unsightly symptoms of this chronic condition. Of those who had modified their routines, more than 91 percent reported it had helped improve their appearance.

More than 76 percent of the patients reporting successful results said they wash their face at least twice a day, and nearly 70 percent said they use their fingertips only, rather than a wash-

cloth, as a means of avoiding abrasion. Most of these patients reporting using a mild soap (51 percent) or non-soap cleanser (42 percent), and nearly 60 percent said they use a moisturizer. Very few said they use astringents (10 percent), exfoliating agents (5 percent) or other products that may aggravate sensitive skin.

Sixty-one percent of the survey respondents said they also use sunscreen to protect against sun exposure that aggravates rosacea in many patients. Besides the sun, and certain skin-care products, other common rosacea triggers include emotional stress, hot or cold weather, alcohol, spicy foods, strenuous exercise, hot baths and heated beverages.

Rosacea usually first appears after age 30 as a redness on the cheeks, nose, chin or forehead that comes and goes. Left untreated, the redness becomes

ruddier and more permanent. Dilated blood vessels may appear on the surface of the skin, and bumps and pimples often develop. The eyes also may become irritated, and in advanced cases the nose may grow swollen, red and bumpy from excess tissue.

More than 94 percent of the patients in the survey said they use topical medication for their rosacea, and 81 percent said that it helped reduce their symptoms. Nearly 47 percent of the women also reported using standard makeup and 14 percent said they use green-tinted makeup to help conceal redness. More than 27 percent of the men said they use shaving lotion, although such products have been reported to cause irritation in some patients if they contain alcohol.

In addition to alcohol, other ingredients reported to burn, sting or aggravate the skin of various rosacea sufferers include witch hazel, fragrance, menthol, peppermint and eucalyptus oil.

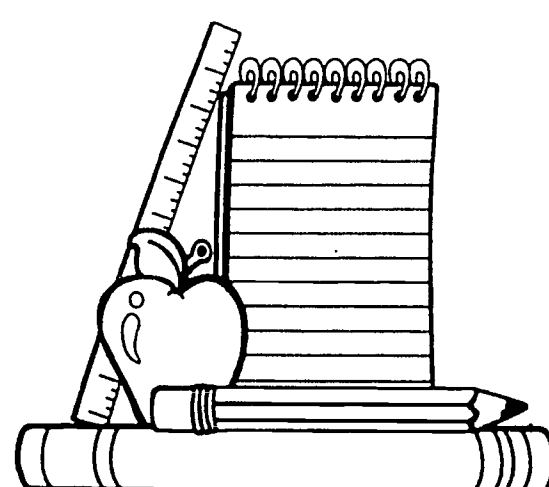
