## ORDINANCE 19-04

### ORDINANCE LEVYING AND ASSESSING TAXES OF THE NILES-MAINE DISTRICT LIBRARY, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2019, AND ENDING JUNE 30, 2020

BE IT ORDAINED by the Board of Library Trustees of the Niles-Maine District Library as follows:

Section 1: That the sum of SIX MILLION NINE HUNDRED EIGHTY THREE THOUSAND SEVEN HUNDRED TWENTY FIVE AND NO/100 dollars (\$6,983,725) be and the same is assessed and levied from and against all taxable property within the limits of the said Niles-Maine District Library as the same is assessed and equalized for State and County purposes for the current year, 2019, and are to be applied in liquidation of the appropriations heretofore made by Ordinance 19-03 adopted by the Board of Library Trustees of the Niles-Maine District Library at a meeting thereof convened and held on June 19, 2019, and duly published as provided by law; the various objects and purposes for which said appropriations were made and are set forth under the column entitled "Appropriation" and the specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:
